District Academic Senate (DAS) President, Julie Oliver, Reports:

Dual Enrollment-The District Equity and Student Success Committee (DESSC) brought a work group charter for the DAS to review at the Feb 1st meeting. The work group will be focused on the following tasks:

- Providing input on the expansion of College and Career Access Pathways (CCAP) and non-CCAP programming and offerings across the district
- Sharing and discussing college equity-minded dual enrollment models, practices, and processes to make
 recommendations on best practices for the delivery of high-quality dual enrollment programs in Los Rios
 CCD. This workgroup may also consider dual enrollment models, practices and processes at other
 community colleges in California and the nation.

The DAS looks forward to receiving and considering the DESSC report on the outcome of this work group. College Academic Senate Presidents are currently making recommendations for faculty appointments to the work group.

ARC Academic Senate President, Alisa Shubb, Reports:

- ARC Academic Senate passed two resolutions:
 - that the ARC Academic Senate will ensure, through direction given to the Curriculum Committee, that equity, diversity, inclusion, cultural responsiveness, and anti-racism are appropriately reflected in the course outlines of record,
 - that the ARC Academic Senate work with college administration to ensure sufficient allocation and/or development of cooperative, effective research support to faculty working on Program Review, and that this research support be provided within the timeframe designated by the Program Review Committee.

- Revisions to our Constitution and Bylaw are underway. The subcommittee is focused on creating a more inviting and inclusive environment for our local senate meetings.
- CRC's Distant Education & Information Technology (DEIT) committee, as well as all of our senate, are excited to provide creative and innovative instruction modalities as we move forward in exploring Hyflex and Syncflex modalities.
- We look forward to hosting our Accreditation ISER Team, Tuesday, Feb 22nd.

FLC Academic Senate President, Eric Wada, Reports:

- The FLC Academic Senate recently had a good discussion about instructors using their own individual classroom data to reflect on ways to eliminate equity and opportunity gaps in the classroom as a start to institution-wide conversations. We recognize that there are also institutional and systemic ways to improve equity, and we are looking forward to being involved in conversations to identify and reflect on institutional and systemic improvements that can support student equity.
- We affirmed minor changes to our college's Equity Statement.
- We welcome professor of Psychology, Dr. Danielle Beck to the Senate Executive Team as the new Academic Senate Vice President.
- We are preparing for our Accreditation team visit at the end of February.

SCC Academic Senate President, Lori Petite, Reports:

- As we honor Black History Month, we welcome the many professional development opportunities to assist us in becoming better educators as we serve our black and African-American students.
- We appreciate the opportunity to engage in the hiring process for full-time faculty this Spring. As the
 faculty appointments for these committees have been completed, recommendations are being compiled
 that might enhance, clarify, or strengthen the language of the hiring manual in future iterations to help
 support the diversity of the committees and streamline processes.
- The SCC Academic Senate engaged in multiple discussions last fall regarding District's proposed new Strategic Planning process. Summarized feedback, questions, and concerns have been provided to our college and district administration.
- The SCC Academic Senate offers heartfelt sympathy to the family of SCC student, Emma Roark. Emma was reported missing by her family on January 27th after she went for a walk and did not return home. Her remains were found a few days later along the American River parkway in Rancho Cordova. We send our deepest sympathy and condolences to Emma's family, friends, and the SCC community who knew her.
- The SCC Academic Senate also extends heartfelt condolences to the family of Professor Mike Richardson, who passed away suddenly in January. Professor Richardson taught in the Physics department at SCC for approximately 35 years. He was a tenacious champion of the faculty voice and previously served on our

Los Rios CCD Academic Senate Call to Action

Approved Tuesday November 17, 2020

The four Los Rios Colleges and the District Academic Senate support the Academic Senate of California Community Colleges (ASCCC) Fall 2019 Plenary Resolution "Support Infusing Anti-Racism/No Hate Education in Community Colleges". Specifically, to the following Resolved statements from that resolution:

- denounce racism for its negative psychological, social, educational, and economic effects on human development throughout the lifespan;
- take steps to not only strive for a greater knowledge about and the celebration of diversity but
 also to support deeper training that reveals the inherent racism embedded in societal
 institutions in the United States, including the educational system, and asks individuals to
 examine their personal role in the support of racist structures and the commitment to work to
 dismantle structural racism; and
- infuse Anti- Racism/No Hate Education in all its activities and professional development opportunities to the degree that doing so is feasible.

To achieve this, our Academic Senates are committed to:

- 1. Include a discussion of anti-racism/no-hate education on agendas. Remembering that we do not have to have an answer to start a conversation.
- 2. Prioritize culturally responsive curricular redesign with our curriculum committees.
- 3. Acknowledge, without assigning blame, that the structure of our colleges houses the biases and prejudices of their founding times. Those biases have privileged some and disadvantaged others, particularly African American and LatinX communities.
- 4. Prioritize the evaluation of hiring and evaluation processes with an equity lens.
- 5. Request services from the ASCCC about any of these topics if needed.
- 6. Evaluate our academic senates and find the voices among our faculties missing in governance. Find ways to empower those voices.
- 7. Work with our administrations, classified professional colleagues, and students to find constructive ways students can express themselves about structural and historical biases that exist.
