Course Deletions

American River College

1. **FITNS 339 Multi Sport Training for Fitness (1 unit)**

Justification: This course is no longer serving the needs of our students.

2. **FITNS 412 Taekwondo I (1 unit)**

Justification: We no longer offer Taekwondo.

3. **FITNS 416 Taekwondo II (1 unit)**

Justification: We no longer offer Taekwondo.

4. **FITNS 417 Taekwondo III (1 unit)**

Justification: We no longer offer Taekwondo.

5. **SPORT 345 Golf, Intercollegiate-Women (3 units)**

Justification: We are no longer offering a Women's golf team at ARC.

Cosumnes River College

1. **POLS 311 International Political Economy (3 units)**

Justification: Course has been converted into an Honors offering and, additionally, is no longer accepted as a lower division transfer requirement.

2. **WELD 125 Introduction to the Gas Metal Arc Welding & Gas Tungsten Arc Welding Processes (1.5 units)**

Justification: The WELD 125 1.5 unit course is no longer needed. The course is being replaced with WELD 153 which will be a 2.5 unit course. The content information and skills are found in courses 126, 127, 128 AND 129. This course is also being removed from the Certificates and Degrees.

Folsom Lake College

1. TA 427 Stagehand Pre-Apprenticeship (2 units)

Justification: This course no longer meets the needs of our students. TA 427 is being replaced with TA 498, Work Experience in Theater Arts, in the Technical Theatre certificate so that our students can not only receive on the job training, but may also have the opportunity to receive compensation for those hours.

New to District Courses

American River College

1. INSTL 100 Orientation and OSHA 10 (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course focuses on orienting and offering the student the information and basic knowledge to be successful and safe as the newest member of the workforce. Orientation provides points of contact and information pertinent to the Training Center, the Council, and the United Brotherhood of Carpenters (UBC). Occupational Safety and Health Administration (OSHA) 10 is covered to ensure safe practices are reinforced. Safe use of hand and power tools along with material handling are covered in depth. Job site etiquette, knowledge, rules, and documentation are discussed. This course is the equivalent of course number 001 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

2. INSTL 102 Substrate Preparation (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course focuses on preparing the substrate to receive a finished flooring product or process. We explore the most effective ways to adjust imperfections or contaminants. Special focus is given for using Portland-based cementitious and Gypsum-based patching compounds. Wood underlay installation and issues are discussed. Quantitative and qualitative moisture test procedures are also covered. This course is the equivalent of course number 102 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

3. INSTL 103 Concrete Polishing (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course is an introduction to the process of concrete polishing. The concepts, skills, and processes covered will prepare students to identify jobsite conditions with concrete polishing, defects and remedies, cracks, saw cuts, tooling, equipment and safety. Emphasis will be placed on selecting the proper tooling, Moh's hardness testing procedure, chemicals involved in the polishing process, and checking results through a gloss meter. This course is the equivalent of course number 103 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

4. INSTL 104 Adhesives and Layout (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This class focuses on the types of adhesives used in floor covering and application methods. The concepts are utilized in the installation of square resilient tile. A straight lay and 45 degree installation are performed. Proper cutting around door jambs and obstacles is covered. This course is the equivalent of course number 104 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

5. INSTL 105 Wall Base (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course focuses on various wall base installations related to common straight and toed wall base, as well as specialty base including resilient millwork base, tapered base, contoured base,

stackable trim molding sanitary base, and caulk tight base. Proper cutting, gluing, and installation processes are covered. This course is the equivalent of course number 105 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

6. INSTL 106 Introduction to Resilient (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course focuses on the different types of resilient flooring. It covers homogeneous, heterogeneous, linoleum, and rubber products along with common installation techniques and methods. A flat lay installation is completed with properly constructed seam using the underscribe method. Heat welding is also introduced including the tools, methods, and concepts of a properly welded seam. This course is the equivalent of course number 201 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

7. INSTL 107 Complex Layout (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course focuses on the principles encountered in complex layouts. Students demonstrate how to scale down a basketball court, hockey rink, or some other large-scale design mathematically by means of a sketch for the purposes of a full-scale project. After working out the math and creating a scaled sketch, students install the project based on our drawing. This course is fundamental to the skills and abilities of an accomplished floor layer. This course is the equivalent of course number 202 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

8. INSTL 110 Resilient Linoleum (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course covers linoleum installation and seaming. It addresses the process used to cut, fit, and install linoleum, including seam creation and sealing. The process of how to properly handle, store, and plan for a linoleum installation is also covered. A review of linoleum history and how it's made and used in today's buildings is also covered. This course is the equivalent of course number 203 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

9. INSTL 111 Hardwood Installation (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course follows National Wood Flooring Association (NWFA) standards. This class provides a third-party certification on hardwood floor installation and testing for both glue down and nail installation. This course is the equivalent of course number 204 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

10. INSTL 112 Glue Down Carpet Installation (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course is an introduction to carpet and installation. It focuses on matching patterned carpets. A review of carpet tools, fibers, layout, and seam cutting techniques is included. Glue down installation and the tools used in the process are covered. This course is the equivalent of course number 205 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

11. INSTL 113 Stretch-In Carpet Installation (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This class focuses on a stretch-in installation as opposed to a glue-down installation covered in the previous class. Hot melt seaming, the use of the Kool-Glide seam system, and properly making T-Seams are covered. This course is the equivalent of course number 301 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

12. INSTL 114 Introduction to Flash Cove (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course covers the many different processes and techniques applicable to flash cove installation. It focuses on proper cove cap and cove stick installation and the understanding of the concepts of flash cove installation; also known as internal base installation. This course serves as an important step in understanding the fundamentals, terminology, and skills required in all flash-coved installations, including T-template, Pattern-Scribed, Boot-Plug, and Sheet Installation with a contrast to the full pattern method. This course is the equivalent of course number 302 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

13. INSTL 115 Resilient Flash Cove (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course brings together concepts from INSTL 106 (Introduction to Resilient) and INSTL 114 (Introduction to Flash Cove) to complete a flash cove installation using the hand-fit method using vinyl sheet goods. The boot-plug and v-plug outside corner option are also covered. This course is the equivalent of course number 303 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

14. INSTL 120 Hardwood Sand and Finish (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This class focuses on the methods, materials, and equipment utilized when finishing hardwood floors. It discusses game lining and artwork applications as well as water-based and oil-based finishes. It also touches on the main difference between sanding and finishing a raw wood installation versus re-sanding a previous installation, especially of pre-finished factory wood. This course is the equivalent of course number 304 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

15. INSTL 121 Advanced Heat Welding (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This class focuses on methods required for more complex tasks such as welded seam intersections, difficult flash cove situations, and curved or circular seams. Advanced welding techniques along with cold weld rubber and other resilient flooring seams are covered. This course is the equivalent of course number 305 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

16. INSTL 122 Resilient Stairs (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course covers the planning and preparation required for stair installations, which includes precise measurements, careful scribing, and cutting. These tasks are explained in this course

using sheets of resilient material or standard size prefabricated stringers, treads, and risers. It also covers installation of single piece tread and riser sections on steps with various nosing types, including those with angular ADA-compliant profiles and flash cove resilient flooring on stairs. This course is the equivalent of course number 401 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

17. INSTL 123 Polished Overlay (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course combines the skills and fundamental concepts of surface preparation and concrete polishing. Pouring and finishing a topping requiring a high degree of skill and attention to detail is covered. This course is the equivalent of course number 402 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

18. INSTL 124 Carpet Stairs (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course covers the installation of carpet on floating stairs, winder stairs with balusters, and simple box stairs. It also briefly covers the laying of more intricate carpet tile found in some flooring installations. This course is the equivalent of course number 403 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

19. INSTL 125 Turf and Rugmaking (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course describes the history and characteristics of artificial turf and explains how it is manufactured and installed. It also introduces hand-sewing carpet seams and includes a rugmaking project. This course is the equivalent of course number 404 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

20. INSTL 126 Custom Insets (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Flooring Install Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course covers resilient installations involving a wide array of colorful symbols, complex designs, and other permanent markings as a custom inset used for visual appeal or identity to the use of the building, room, or area. It focuses on the placement of the precisely laid outlines and circles that may be specified under these circumstances. These challenging installations will be accomplished in the process of the test-out procedure. This course is the equivalent of course number 405 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Flooring Install Carpentry Apprenticeship program.

21. INSUL 161 Residential Insulation Blow-In (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Insulator Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course introduces the Insulator Apprentice to insulation installation. Topics include insulation and vapor barrier types and installation processes. This course is the equivalent of course number 504 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the American River College Carpenters' Apprenticeship program. It is a required course in the State of California mandated Insulator Apprentice program.

22. INSUL 163 Spray In Foam Application (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Insulator Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course introduces the Insulator Apprentice to benefits, dangers, and types of spray foam applications. This course is the equivalent of course number 507 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the American River College Carpenters' Apprenticeship program. It is a required course in the State of California mandated Insulator Apprentice program.

23. INSUL 165 Thermal Insulation Sprayed (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Insulator Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course introduces Insulator Apprentices to the basic application of sprayed thermal insulation. This course is the equivalent of course number 509 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the American River College Carpenters' Apprenticeship program. It is a required course in the State of California mandated Insulator Apprentice program.

24. INSUL 181 Walls, Slabs, and Joints (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Insulator Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course introduces Insulator Apprentices to curtain wall, head of wall, and edge and floor slab insulation. This course is the equivalent of course number 505 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the American River College Carpenters' Apprenticeship program. It is a required course in the State of California mandated Insulator Carpentry Apprenticeship program.

25. INSUL 183 Expansion Joints (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Insulator Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course introduces the Insulator Apprentice to expansion joints, their importance and function, as well as proper installation methods. This course is the equivalent of course number 508 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the American River College Carpenters' Apprenticeship program. It is a required course in the State of California mandated Insulator Apprentice program.

26. INSUL 191 Introduction to Firestop (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Insulator Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course introduces Insulator Apprentices to the basic application of firestop. Firestop Certification and an introduction to life safety will also be covered. This course is the equivalent of course number 502 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the American River College Carpenters' Apprenticeship program. It is a required course in the State of California mandated Insulator Apprentice program.

27. INSUL 193 Fire Proofing (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Insulator Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course introduces Insulator Apprentices to fire proofing and components used in the fire proofing process. Hilti and Specified Technologies Incorporated (STI) certification may be obtained. This course is the equivalent of course number 506 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the American River College Carpenters' Apprenticeship program. It is a required course in the State of California mandated Insulator Carpentry Apprenticeship program.

28. INSUL 195 Fire Stop II Specialty Systems (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Insulator Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course introduces Insulator Apprentices to the shaft wall system, grease and air ducts, duct wrap insulation, and access door installation. This course is the equivalent of course number 511 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the American River College Carpenters' Apprenticeship program. It is a required course in the State of California mandated Insulator Apprentice program.

29. SCFLD 114 Ladder Access and Stair Tower (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Scaffold Erector Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course introduces the Scaffold Erector Apprentice to the safety procedures and industry regulations for erecting tube and clamp scaffold systems. This course is the equivalent of course number 309 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Scaffold Erector Carpentry Apprenticeship program.

30. SCFLD 116 Scaffold Containment (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Scaffold Erector Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course introduces the Scaffold Erector Apprentice to scaffold containment systems and industry-related safety procedures associated with those systems. This course is the equivalent of course number 311 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Scaffold Erector Carpentry Apprenticeship program.

31. SCFLD 161 Tiebacks (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Scaffold Erector Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course familiarizes apprentices with the equipment and the procedures to safely stabilize and brace scaffold on the job-site. This course is the equivalent of course number 313 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Scaffold Erector Carpentry Apprenticeship program.

32. SCFLD 163 Reshoring (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Scaffold Erector Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course familiarizes apprentices with the equipment and the procedures to safely reshore a scaffold on the job-site. This course is the equivalent of course number 314 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Scaffold Erector Carpentry Apprenticeship program.

33. SCFLD 165 Slopes and Vessels (1.5 units)

Prerequisite: None.

Enrollment Limitation: Student must be a registered Scaffold Erector Apprentice.

22.5 hours lecture, 13.5 hours laboratory

This course familiarizes apprentices with the equipment and the procedures to safely erect scaffolding on slopes and in vessels. This course is the equivalent of course number 315 for the Carpenter's Training Center of Northern California (CTCNC).

Justification: This course is part of the Carpenters' Apprenticeship program at American River College. It is a required course in the State of California mandated Scaffold Erector Carpentry Apprenticeship program.

Cosumnes River College

1. WELD 153 Introduction to Welding Codes (2.5 units)

Prerequisite: None.

Advisory: WELD 100 with a grade of "C" or better

45 hours lecture

Introduction to Welding Codes covers the welding requirements for any type of welded structure made from commonly used carbon and low-alloy steel construction, boiler and pressure vessels and pipe welding. Topics include the welding construction industry, rules, regulations, and the principles, requirements, and methods of inspection. It covers weld measurements and discontinuities for evaluation acceptance using a variety of tools. It also emphasizes the lines of communication between the plant managers, welders, welding engineers, design/project engineers, welding foreman/supervisors, shop or field superintendents, and reporting supervisors.

This course offers preparation for the Certified Welding Inspector Examination given by the American Welding Society. Welding codes covered are AWS, ASME Section IX and API 1104.

Justification: The WELD 153 is needed to introduce welding students to welding codes in-order to become familiar to inspection procedures in the construction industry. Welding students that graduate from CRC become welding inspectors and this course will help prepare those students to become certified welding inspectors in the welding industry.

Folsom Lake College

1. **CISD 351 Data Science Foundations (4 units)**

Prerequisite: None.

Advisory: CISD 355 or CISP 300 with a grade of "C" or better

54 hours lecture, 54 hours laboratory

This course provides a comprehensive introduction to the foundational concepts and practices in data science across various domains. It covers key topics such as inferential thinking, random variables, normal distributions, hypothesis testing, and confidence intervals for making data-driven decisions. Students will work with real world data sets to gain hands-on experience in data collection, sampling techniques, and in conducting observational and experimental studies. Students will explore methods for identifying relationships, predicting outcomes, and will develop skills in writing programming scripts, creating and interpreting visualizations, and in effective communication of insights. Ethical considerations and the impact of data on society are integrated into the course.

Justification: This course provides a comprehensive introduction to the foundational concepts and practices in data science across various domains. It covers key topics such as inferential thinking, random variables, normal distributions, hypothesis testing, and confidence intervals for making data-driven decisions. Students will work with real world data sets to gain hands-on experience in data collection, sampling techniques, and in conducting observational and experimental studies. Students will explore methods for identifying relationships, predicting outcomes, and will develop skills in writing programming scripts, creating and interpreting visualizations, and in effective communication of insights. Ethical considerations and the impact of data on society are integrated into the course.

2. **CISD 355 Python for Data Science (4 units)**

Prerequisite: None.

54 hours lecture, 54 hours laboratory

This course is an introduction to computational thinking and quantitative reasoning using Python. It teaches critical concepts and skills in computer programming and uses the language as a vehicle to impart the principles, practices and tools to handle data and gain insights from data using datasets from across STEM and other disciplines. Python libraries and other tools are used for simple data analysis and data visualization. It is designed to prepare students for further coursework in data science, and supports students in other disciplines that explore data.

Justification: The need to manage, process, analyze and visualize data and make predictions has permeated all areas of science and technology. This course is designed to introduce the programming language Python as a vehicle to impart the principles, practices and tools to process data and gain insights from data to Computer Science, STEM and non-STEM majors.

3. DANCE 327 Ballet Conditioning: Pre-Pointe & Pointe I (1 unit)

Prerequisite: DANCE 320 (Ballet I), 321 (Ballet II), 322 (Ballet III), or 323 (Ballet IV) with a grade of "C" or better, or instructor consent.

54 hours laboratory

This course covers the elements and rigors necessary to prepare for dancing on pointe. Students will apply conditioning exercises kinesthetically, and will also learn anatomy through lecture on proper physical alignment. Emphasis is on assessing readiness, ensuring that the strength and structure of the body is appropriate for pointe work, lessening the risk of injury in pointe shoes. Students will be required to supply appropriate dance attire and dance shoes, which will incur a fee. The course will be taken in flat ballet shoes. Students may wear pointe shoes with instructor approval only.

Justification: Ballet Conditioning: Pre-Pointe & Pointe I, as a member of the ballet family, provides a necessary foundation for those pursuing a transfer to a university dance department ballet program. This course will be a part of FLC's A.A. in Dance Studies.

4. DANCE 328 Ballet Conditioning: Pre-Pointe & Pointe II (1 unit)

Prerequisite: DANCE 320 (Ballet I), 321 (Ballet II), 322 (Ballet III), or 323 (Ballet IV) with a grade of "C" or better, or instructor consent.

54 hours laboratory

This course covers the elements and rigors necessary to prepare for dancing on pointe. Students will apply level II conditioning exercises kinesthetically, and will also learn anatomy through lecture on proper physical alignment. Emphasis is on assessing readiness, ensuring that the strength and structure of the body is appropriate for pointe work, lessening the risk of injury in pointe shoes. Students will be required to supply appropriate dance attire and dance shoes, which will incur a fee. The course will be taken in flat ballet shoes. Students may wear pointe shoes with instructor approval only.

Justification: Ballet Conditioning: Pre-Pointe & Pointe II, as a member of the ballet family, provides a necessary foundation for those pursuing a transfer to a university dance department ballet program. This course will be a part of FLC's A.A. in Dance Studies.

5. EMT 105 Public Safety First Aid (2 units)

Prerequisite: None.

21 hours lecture, 45 hours laboratory

This 21-hour course meets the EMSA Public Safety First Aid, AED and CPR Title 22, Section 100023 requirements and provides new First Aid/CPR responders with the required skills. This

course meets the requirements of CAL FIRE CPR/AED First Aid Training. This course may be taken up to four times for continued professional development or maintaining certification. This course is accredited by the El Dorado County Emergency Medical Services Authority.

Justification: This course was previously approved and utilized throughout the college's service area. PSFA was an "experimental course offering" under EMT 299. This course has been very successful within our high school partners and entry-level community college students seeking rapid employment into CAL FIRE. The intention with this proposal is to move Public Safety First Aid (PSFA) from experimental to permanent. Creating a pathway for students seeking immediate training for entry-level employment as a seasonal firefighter. This course provides information and skills in Public Safety First Aid and CPR, use of the AED and bag mask device valuable to the healthcare professional, and Infant/Child/Adult resuscitation efforts. Upon successful completion, students are eligible for certification from the American Heart Association Basic Life Support for the Healthcare Provider. The AHA BLS Healthcare Provider CPR Certificate along with the Public Safety First Aid (PSFA) Certificate is certification is required for entry-level employment as a Peace Officer, Lifeguard, Firefighter, EMT, Wildland Firefighter, Forestry Technician, Paramedic, and is the prerequisite for many Medical Technology, Nursing programs, Kinesiology programs, and Early Childhood Education programs.

6. **ETHNS 321 African American Policy and Law (3 units)**

Prerequisite: None.

Advisory: ENGWR 300 with a grade of "C" or better

54 hours lecture

This course illuminates the socio-political underpinnings behind landmark legislations and pivotal policy shifts that have impacted African Americans. Through comprehensive analyses of legal documents, court cases, scholarly articles, and firsthand accounts, students will gain insights into the complex interplay between law, power, race, and resistance. From the era of Reconstruction and the establishment of Jim Crow laws, through the Civil Rights Movement, and up to current legislative challenges and reforms, students will journey through the evolving landscape of African American legal history.

Justification: The purpose of this course is to continue expanding course offerings in Ethnic Studies, more specifically African American Studies in order to develop the AA and ADT in African American Studies and meet the TMC requirements so that students who want to major in this discipline can do so.

7. **ETHNS 361 Chicana/o/x Latina/o/x Policy and Law (3 units)**

Prerequisite: None.

Advisory: ENGWR 300 with a grade of "C" or better

54 hours lecture

This course offers a comprehensive exploration of the myriad ways in which legislation and policies have influenced and shaped the experiences of these vibrant Chicana/o and Latina/o communities in the United States from 1848 to the present time. From the Treaty of Guadalupe

Hidalgo, to the early days of the Bracero Program to the complexities of contemporary immigration debates, students will traverse through a historical timeline marked by both challenges and resilience. We will dissect pivotal moments, including the Chicano Movement, the evolution of labor rights, debates surrounding bilingual education, and the ongoing challenges surrounding immigration reform. Through a blend of academic readings, multimedia resources, firsthand narratives, and engaged class discussions, students will gain profound insights into the multi-faceted ways federal policies have affected the socio-political and economic landscapes of Chicano and Latino communities.

Justification: The purpose of this course is to continue expanding course offerings in Ethnic Studies, more specifically Chicana/o and Latina/o Studies in order to develop the AA and ADT in Chicana/o Studies and meet the TMC requirements so that students who want to major in this discipline can do so.

8. FT 100 Fire Service Conditioning and Fire Academy Preparation (2.5 units)

Prerequisite: None.

20 hours lecture, 75 hours laboratory

This course covers strength training, flexibility and overall physical conditioning to prepare a student to take the Candidate Physical Ability Test. Additional topics include personal skills development, lifestyle modifications, and firefighting equipment familiarization.

Justification: This course will prepare students for the physical exertion of the fire academy and provide a foundation that will serve them for years to come in the fire service. In addition to strength and cardiovascular training, there will be an introduction to State Fire Marshal Fire Fighter 1 Academy skills.

Sacramento City College

1. BIOL 302 Concepts of Human Anatomy and Physiology (3 units)

Prerequisite: None.

Advisory: AH 311, BIOL 290, ENGWR 300, or ESLW 340 with a grade of "C" or better

54 hours lecture

This lecture course provides an overview of the basic anatomy and physiology of all 11 body systems and is required for students entering the licensed vocational nursing and occupational therapy assistant programs. The course emphasizes the direct connection between human activities (i.e. diet and lifestyle choices) and health of the body. It is designed for students having little or no background in the biological sciences. The course is also open to those intending to pursue studies in the biological sciences who need to strengthen or develop a vocabulary in human anatomy and physiology.

Justification: Biology 302 is required for allied health programs and provides students with an overall understanding of the human body.

2. MATH 386 Preparation for Calculus (4 units)

Prerequisite: None.

72 hours lecture

This class is designed for Science, Technology, Engineering, and Mathematics (STEM) majors who are not fully prepared for calculus. The course will focus on the intuitive and conceptual development of ideas formally covered in calculus. Topics will include function analysis, especially polynomial, trigonometric, rational, exponential, and logarithmic functions. This course will build algebraic and trigonometric skills required for success in calculus.

Justification: Due to AB1705, we are not be able to require or recommend calculus students to enroll in preparatory coursework that is not part of the major. This course has been developed to provide intensive instruction and practice in the core mathematical skills, competencies, and concepts necessary for success in a first semester calculus course.

3. MATHS 61 Support for Calculus II (2 units)

Prerequisite: Placement through the assessment process.

Corequisite: MATH 401

36 hours lecture

This course provides intensive instruction and practice in the core mathematical skills, competencies, and concepts necessary for success in MATH 401: Calculus II. Students taking this course must be concurrently enrolled in the corresponding section of MATH 401. The content of this course is designed to provide arithmetic, algebra, geometry, trigonometry, and skills support to students as they learn preparatory concepts in their Calculus II course. Topics and homework assignments may be connected to assignments in the Calculus II course. This course is graded Pass/No Pass.

Justification: Due to AB1705, we may not be able to require or recommend Calculus students to enroll in preparatory coursework that is not part of the major. This course has been developed to provide intensive instruction and practice in the core mathematical skills, competencies, and concepts necessary for success in Calculus 2.

4. MATHS 66 Support for Calculus for Biology and Medicine II (2 units)

Prerequisite: Placement through the assessment process.

Corequisite: MATH 356

36 hours lecture

This course provides intensive instruction and practice in the core mathematical skills, competencies, and concepts necessary for success in MATH 356: Calculus for Biology and Medicine II. Students taking this course must be concurrently enrolled in the corresponding section of MATH 356. The content of this course is designed to provide arithmetic, algebra, geometry, trigonometry, and skills support to students as they learn preparatory concepts in their

Calculus for Biology and Medicine II course. Topics and homework assignments may be connected to assignments in MATH 356. This course is graded Pass/No Pass.

Justification: Due to AB1705, we may not be able to require or recommend Calculus students to enroll in preparatory coursework that is not part of the major. This course has been developed to provide intensive instruction and practice in the core mathematical skills, competencies, and concepts necessary for success in Calculus for Biology and Medicine II.

5. **MATHS 86 Support for Preparation for Calculus (2 units)**

Prerequisite: None.

Corequisite: MATH 386

36 hours lecture

This course provides intensive instruction and practice in the core mathematical skills, competencies, concepts, and study skills necessary for success in MATH 386: Preparation for Calculus. Students taking this course must be concurrently enrolled in the corresponding section of MATH 386. The content of this course is designed to provide arithmetic, algebra, geometry, trigonometry, and skills support to students as they learn preparatory concepts in their MATH 386 course. Topics and homework assignments may be connected to assignments in the MATH 386. This course is graded Pass/No Pass.

Justification: This course provides intensive instruction and practice in the core mathematical skills, competencies, concepts, and study skills necessary for success in MATH 386: Preparation for Calculus

6. **SOC 386 Practicum in Sociology, Community Studies, and Community Health Work - LAB (1 unit)**

Prerequisite: CSP 305 or SOC 385 with a grade of "C" or better

54 hours laboratory

Upon completion of SOC385/CSP305, this course allows students to continue to sociologically explore an internship work experience. Students will identify and secure an instructor-approved internship and will use the sociological perspective to analyze the organizational structures and processes of the workplace. Students will utilize learned techniques to address common problems within social service and community-based organizations. Students will be required to fulfill 54 hours of instructor-approved paid or volunteer work for one unit of lab.

Justification: This is a core lab course in the Community Studies program that places students directly in a work site to gain experience in the fields of social work, human services, and/or community health. This course allows students who only completed two units of SOC385/CSP305 to complete one additional unit of practicum lab in order to meet the three-unit practicum requirement for the Social Work and Community Studies degree and certificate.

7. **SPORT 334 Off Season Conditioning for Flag Football (0.5 - 3 units)**

Prerequisite: None.

Enrollment Limitation: In order to take the SPORT 334 class, each student must: 1) be listed as a student athlete, by the head coach, on the official team roster; and 2) obtain medical clearance, including a physical performed by a licensed physician. Students should contact the instructor for process and required forms. Once enrolled, the student must demonstrate level skills as determined by the coaching staff to remain enrolled in this course.

27 - 162 hours laboratory

This course will involve sport specific training and technical skill development in the sport of flag football for off-season student athletes. Course content will include: sport specific skill development, sport specific strength training, speed development, agility training, plyometric drills, cardiovascular conditioning, and an increase in flexibility.

Justification: This course will provide off-season flag football athletes with the necessary physical and technical training needed to increase speed, agility, quickness, power, strength, and conditioning to prevent injury as well as preparing them for their competition season.

8. **SPORT 335 Flag Football, Intercollegiate-Women (3 units)**

Prerequisite: None.

Enrollment Limitation: In order to take the SPORT 335 class, each student must: 1) be listed as a student athlete, by the head coach, on the official team roster; and 2) obtain medical clearance, including a physical performed by a licensed physician. Students should contact the instructor for process and required forms. Once enrolled, the student must demonstrate level skills as determined by the coaching staff to remain enrolled in this course.

175 hours laboratory

This is an advanced course designed to provide specialized training for competition against other community college programs. Fundamentals, rules, and individual and/or team strategies appropriate to intercollegiate flag football athletic competition will be expected of the competitors.

Justification: To provide a competitive intercollegiate experience for student athletes that is new to the District. It also meets the needs of those student athletes who want to enhance skills and training for the purpose of transferring and competing at the four year level in flag football.

PROGRAM PROPOSALS

Program Deletion(s)

Folsom Lake College

1. Emergency Medical Studies

Justification: The Emergency Medical Technology and Fire Technology departments have developed an Emergency Services certificate to better suit the needs of our students.

New Programs

Folsom Lake College

1. Emergency Services

This program prepares students to function as certified Emergency Medical Technicians. Training topics include the skills necessary to provide emergency medical care at a basic life support level with a fire, ambulance, or other specialized service. This program is conducted in compliance with Title 22, Division 9, Chapter 2 of the California Code of Regulations and Emergency Medical Technician (EMT).

Justification: This Certificate of Achievement will replace the outdated "EMT Certificate." The intention is to offer a wide variety of courses that can count toward a usable certificate that has value and distinction with the community of emergency services.

2. Fire Technology

Employment within the fire service is highly respected, lucrative, and rewarding. Folsom Lake College's Fire Technology Program is designed to provide the student with a skill set applicable to the job market along with the knowledge and comprehension needed to successfully obtain positions in the fire service. The curriculum serves as an in-service program as well as a pre-employment program for students seeking employment or advancement in all related fields of emergency service.

Justification: This program proposal validates industry related coursework received from Folsom Lake College in Fire Technology and connects students to a degree program within their community. With a marked census population growth in and around Folsom, the demands from our industry partners are depending on Folsom Lake College to provide the necessary education and training needed to meet entry-level firefighting jobs. Addressing the need to provide educational opportunities in the service area of the college ensures that students will further invest in their community college instead of traveling to the far outskirts of the county to attend a Fire Technology Program. These barriers can be removed with the approval of an A.S. Degree in Fire Technology.

3. Fire Technology

Employment within the fire service is highly respected, lucrative, and rewarding. Folsom Lake College's Fire Technology Program is designed to provide the student with a skill set applicable to the job market along with the knowledge and comprehension needed to successfully obtain positions in the fire service. The curriculum serves as an in-service program as well as a pre-employment program for students seeking employment or advancement in all related fields of emergency service.

Justification: The purpose for creating a Certificate of Achievement (COA) within Fire Technology is to afford students who may forgo an A.S. degree in Fire Technology an opportunity to hold a certificate that is recognized within the industry and has value for career advancement.

Sacramento City College

4. **Honors**

Students who have completed at least 15 units of approved Honors coursework earn a Certificate of Achievement noted on the transcript. Students may also join The Sacramento City College (SCC) Honors Program, a community of students and faculty who are dedicated to the pursuit of intellectual and personal enrichment in a diverse and challenging academic environment. There are many benefits to being an active member of the program. Completion of the program with a cumulative grade point average (GPA) of 3.2 or better allows students to take advantage of transfer agreements with highly selective colleges and universities through the Honors Transfer Council of California and to participate in the Transfer Alliance Program at UCLA. Honors students must meet with a counselor to ensure completion of SCC graduation and/or transfer requirements. In addition, Honors students must meet at least once with an Honors Faculty Coordinator to ensure completion of the Honors certificate in a timely fashion. To participate in the SCC Honors Program please contact an Honors Faculty Coordinator. For more information, see the Honors Program website.

Justification: This certificate will recognize students' accomplishment of completing 15 honors-qualifying units. This will benefit students for transfer purposes because it highlights this accomplishment. It will also make clear that they have completed our program.

On September 5, 2024, the District issued the 2024 General Obligation Refunding Bonds, Series A and B, totaling \$56,590,000, to refinance certain maturities of the 2002 Election, Series E, and the 2008 Election, Series B, General Obligation Bonds. The refunding bonds carry an interest rate of 5%, with principal payments scheduled to start on August 1, 2025, and end on August 1, 2027.

BACKGROUND:

In 1998, the District and Los Rios Colleges Foundation (Foundation) adopted a Master Agreement whereby the Foundation became an auxiliary organization of the district. All college foundations’ investment activities were combined under the Foundation. Morgan Stanley is the investment consultant for the Foundation.

As an auxiliary organization, the Foundation is not required to operate under GC 53600 investment restrictions. The Foundation Board has a Statement of Rules, Objectives and Guidelines (Statement) to govern the investment of funds, last revised June 2018. The funds should be invested with care, skill, prudence, and diligence with the goal of producing returns equal to or exceeding prevailing standards among foundations of similar asset size, as well as for the protection of funds held in perpetual duration. The Statement defines the investment guidelines for specified asset classes for endowed funds as follows: equities, defined as common stock, convertible preferred stock, convertible bonds, and convertible stock, shall represent 25-60% of the total fund assets; fixed-income securities, defined as investments with maturities greater than one year that pay a fixed rate of return, shall represent 17-50% of the total assets; alternative investments, defined as fund-of-fund investments, shall represent up to 20% of the total fund assets; and cash, defined as maturities shorter than one year, shall represent 2-10% of the total fund assets. In addition, the Statement provides guidelines for investing non-endowed funds based upon the purpose of the donation and the horizon of time for the use of funds. The three non-endowed portfolio funds available are cash management, fixed income, and balanced funds.

STATUS:

The Foundation Quarterly Investment Report, including realized and unrealized earnings, represents the investment activity for the quarter ended September 30th. The Los Rios Colleges Foundation Finance Committee directs the investments of the Foundation. The return for the quarter ended for the endowed portfolio of \$20 million was 5.81% compared to 6.29% for the composite benchmark. The return for the quarter ended for the total managed portfolio of \$27.2 million was 4.78% compared to 5.21% for the composite benchmark. In accordance with generally accepted accounting principles, investments are restated to market value as of each fiscal year-end.

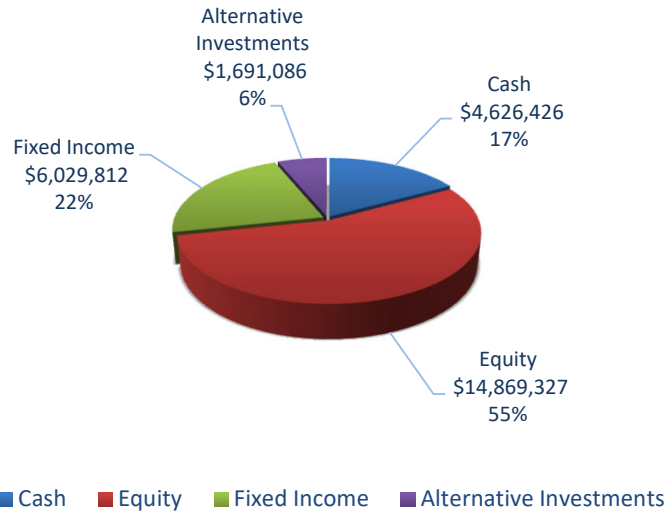

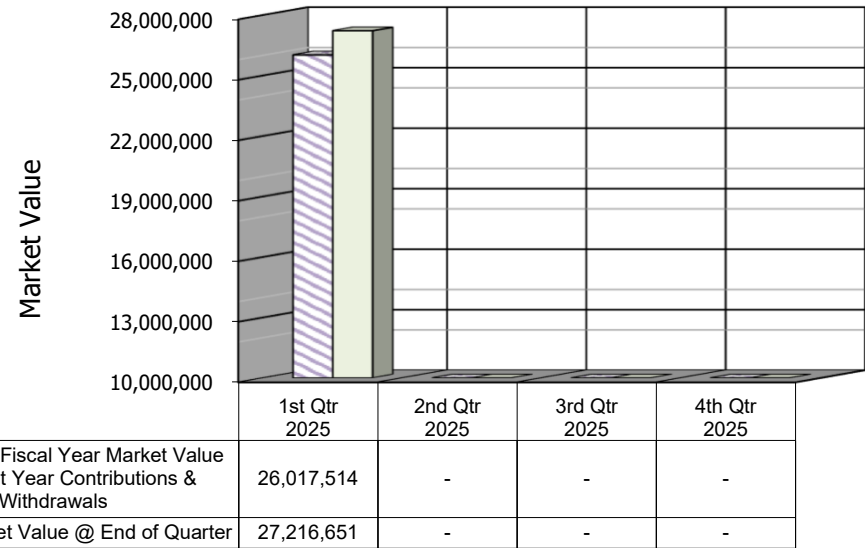

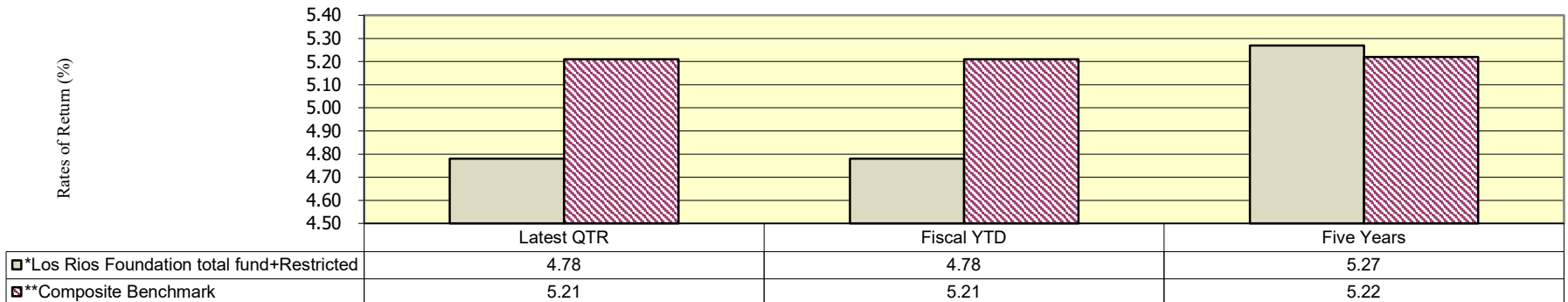
**Asset Allocation as of

BACKGROUND:

The agreement with the Los Rios College Federation of Teachers (LRCFT) provides that at least ten (10) Type A sabbaticals and 2.1 FTE of Type B professional development leaves be granted each year. Type A leaves are leaves of one semester at full pay or one year at half pay. Type B leaves are reassigned time for up to 100% and for up to one year in duration.

The agreement with the LRCFT permits the Professional Standards Committee at each college to recommend the conversion of one or more Type A sabbaticals into equivalent FTE of Type B leaves.

Sabbatical/professional development leave recommendations are presented to the Board in April and November of each year.

The purpose and scope for leaves, as stated in the LRCFT agreement (11.6.4) are as follows:

1. Retraining of applicant to allow for new assignment(s) in a needed area as determined by College and District priorities.
2. Studies, projects or activities that provide staff with opportunities to upgrade academic, technical, and vocational skills and knowledge for current or future assignments.
3. Studies, projects, or activities for the improvement and/or innovation of curriculum, educational delivery systems, student personnel services, or other support services.
4. Studies, projects, or activities for development or revision of certificate or degree programs.
5. Studies, projects, or activities related to feasibility or revision of new or existing programs.
6. Studies, projects, or activities for the enhancement of student access and success at the course, department program or institutional, or community college system levels.
7. Studies, projects, or activities that support completion of college and/or District goals, objectives and priorities.

“Sourcebook of Modern World History: Alternate Pasts/Better Futures”

Proposal: Equitable and anti-racist education is a crucial component of ARC’s mission. Low or zero cost textbooks can be a means of addressing equity, but that alone is insufficient unless the content is inclusive and addresses the challenge of anti-racism head on. Based on my earlier work on an OER world history textbook dedicated to equity, anti-racism, and social justice, I propose to create an OER Primary Source reader for the Modern World History survey. I am proposing a primary source reader instead of a textbook for several reasons: first, because of its versatility. Instructors can use it as their main text, as a supplement to other materials, or even just use it as a resource for themselves but not something they assign. Primary sources also bring the voices of historical actors directly to students instead of being mediated by textbook authors. Additionally, a reader allows me to carefully select the sources to emphasize people and perspectives that have typically been ignored or underrepresented in more traditional materials. A final benefit comes from the fact that the reader will be housed in a digital environment. That will allow me to provide students with a range of sources in multiple mediums: written documents, art and architecture, photographs, artifacts, and even films and recorded speeches. For the project I will take on the significant task of curating a collection of primary sources organized into chapters that are structured around specific themes. I will begin each chapter with an introductory essay laying out those

“Set Up of Newly Renovated Culinary Arts Management Lab Space”

Proposal: Set Up of Newly Renovated Culinary Arts Management Lab Space is a crucial component in the transformation of the CAM program. For the last eight years, Michael has been working diligently to upgrade curriculum and plan for this lab space which includes three unique components - an instructional kitchen, restaurant simulation kitchen, and dining room lab. As the only full-time faculty member in CAM, the daunting task of overseeing the lab set up falls to Michael, which will include outfitting and organizing these new spaces with all the necessary items to reflect industry standards. Once operational, the lab will provide students with a safe, high-quality experience as they complete their CAM courses and prepare for entering the work force. The committee was impressed with Michael's careful planning and thoughtful consideration of how to complete the renovation with minimal impact to student learning. Although the committee was unanimous in its support of Michael's proposal, we also believe that such necessary work as lab set up (particularly after a \$6 million renovation!) should be supported by the college through a one-time FTE allotment.

“Curating and creating OER Materials for PSYC 312 Biological Psychology Lab”

Proposal: I propose to create OER content for PSYC 312 which is a class that currently has no appropriate OER materials or even commercially produced lab manuals. Creating manuals for science and experimental lab courses is a tremendous undertaking and one that falls well outside of regular faculty duties. Once completed, the new lab manual and associated faculty handbook will be a crucial resource for our students and faculty and help address equity gaps by making the content freely accessible. In addition, PSYC 312 is a hands-on learning opportunity, something most students don't experience until they transfer to a four-year university. The committee appreciates Naomi's efforts to create and share materials that will benefit both Psychology majors and non-majors alike.

Annual Salaries are based on a Manager's work year which will not be less than 260 days comprised of work days, holidays, and vacation.

2024-2025 payrates include a continuing improvement of 4% above base payrates for 2023-2024.

After 10 years of full-time service with Los Rios, a longevity increment will be awarded which will be 4% of the appropriate range and step.

An Additional increment of 4% (8.16%) will be awarded after 15 years.

An Additional increment of 4% (12.486%) will be awarded after 20 years.

An Additional increment of 2% (14.736%) will be awarded after 25 years.

Longevity Increments 2, 3 and 4 are based on current step placement plus any previously earned longevity (rate compounded).

For Ranges A, B and C, equivalent full-time service outside of the District will be considered for longevity increment based on a determination from Human Resources. Service in the following classifications at another employer, or service in classifications with substantially similar duties or responsibilities, count toward all longevity service thresholds: Deputy Chancellor, Executive Vice Chancellor, Vice Chancellor, College President, Chief Contract Manager, Associate Vice Chancellor, General Counsel, Chief of Police.

Educational Incentive: An educational incentive payment will be provided to managers possessing an earned doctorate completed at an accredited institution or fully accredited in accordance with the American Bar Association or the California Bar Association. Accredited institution includes a postsecondary institution accredited by an accreditation agency recognized by either the U.S. Department of Education or the Council on Postsecondary and Vocational Education. The Educational incentive will be an annual amount of \$4,175.23.



BACKGROUND:

In October of 2023, the Board of Governors of the California Community Colleges filed revisions to title 5 of the California Code of Regulations related to graduation requirements. The proposed changes to P-7241, Graduation Requirements, include edits to ensure consistency with title 5 of the California Code of Regulations and to address these changes in law. The proposed Board Policy amendments have been vetted through the District’s standard policy development process, including a recommendation of approval from Chancellor’s Cabinet in October of 2024.

STATUS:

The proposed Policy, if adopted, would align the District’s Associate Degree Requirements with the state’s degree requirements under California Code of Regulations, title 5, section 55060. The proposed Board Policy amendments are necessary to reflect current state law.

RECOMMENDATION:

This policy is presented for first reading.

ASSOCIATE DEGREE REQUIREMENTS

1.0 Degree Earned

- 1.1 The degree of Associate in Arts, Associate in Arts for Transfer, Associate in Science, or Associate in Science for Transfer can be earned through any College in the Los Rios Community College District.
- 1.2 The Associate in Arts degree and the Associate in Science degree may be conferred upon students qualified to transfer to a four-year college or university as well as upon those completing their formal education in a two-year vocational program as outlined in the catalog of any of the Colleges of the District. The Associate in Arts for Transfer degree and the Associate in Science for Transfer degree were created by SB 1440 (2010) to allow students to transfer to the California State University with junior status upon the completion of prescribed requirements.
- 1.3 In accordance with law and with the rules and regulations of the California Community College Board of Governors and the Los Rios Community College District Board of Trustees, the requirements for the degree Associate in Arts, Associate in Arts for Transfer, Associate in Science, or Associate in Science for Transfer are defined below.

2.0 Associate in Arts or the Associate in Science Graduation Requirements

2.1 Number of Units

- 2.1.1 Satisfactory completion of a minimum of sixty (60) units of ~~collegiate work~~ degree-applicable lower-division credit courses with a “C” (2.0) grade point average, ~~in a curriculum which the District accepts toward the degree,~~ provided that twelve (12) units must be earned in residence at the ~~College recommending the degree~~ District.

1.3.1.1 All reference to “units” in this policy is to “semester units.”

- 2.1.2 Units of credit are assigned to courses based on the “Carnegie unit,” which assigns one unit of credit for three (3) hours of work by the student per week. Usually this means one (1) hour of lecture or discussion led by the instructor and two (2) hours of outside preparation by the student. In laboratory courses, three (3) hours of work in the laboratory are normally assigned one (1) unit of credit which may include some additional preparation outside of class time.

2.2 Major Field of Study

- 2.2.1 Satisfactory completion of a minimum of eighteen (18) units of focused study in a major ~~field of study~~ or ~~an~~ interdisciplinary area of emphasis

from those specified in the catalog of each College with a minimum grade of “C” or the equivalent for any class in a major ~~field of study~~.

2.2.1.1 A “major” is a focused program of study within a specific discipline, which may include some coursework outside the primary discipline.

2.2.1.2 An “area of emphasis” is an interdisciplinary program of study encompassing a broad range of courses from multiple related academic disciplines, providing students with an academic pathway broader than a specific major but more focused than general education.

2.3 General Education Requirements

2.3.1 Each College of the District will publish in its catalog a specific philosophy of general education. The following will serve as a pattern for the Colleges in the development of their individual philosophy statements.

2.3.1.1 The primary function of education is to transmit from each generation to the next the knowledge and skills requisite to enlarge the comprehension of our place in the universe. Los Rios Colleges are committed to the principle of providing general education which includes: English Composition, Oral Communication and Critical Thinking; Mathematical Concepts and Quantitative Reasoning; Arts and Humanities; Social and Behavioral Sciences; Natural Sciences; Ethnic Studies~~Natural Science, Social and Behavioral Science, Humanities and the Arts, Language and Critical Thinking~~, and other courses that provide for life-long learning and understanding, and that explore the significance of work, production, consumption and leisure in the lives of individuals. All of these are basic and necessary to participate in and contribute to a balanced life in a democratic society that is diverse in its social, cultural, and educational backgrounds.

2.3.1.2 A comprehensive education serves to develop the creativity, critical thinking, ethical behavior, and self-understanding which are essential to the attainment of personal goals and to participate in a society characterized by increasing global interdependence and by rapid and significant change.

2.3.1.3 Therefore, the purpose of general education is to give breadth to the college experience, enhance the ability to learn, and insure an appropriate level of competency. The general education program thus provides coherence to undergraduate education and affords students the opportunity to develop an integrated overview of the diverse fields of human knowledge.

- 2.3.2 The courses allowed by the Colleges of the District for the fulfillment of the general education requirements shall be introductory in nature and usually without course prerequisites. The content of the courses should encompass broad fields of knowledge, covering major principles and their applications to a wide field or fields. The intent should be to provide the students with an understanding and appreciation of a significant body of knowledge and give to the students a basis for evaluating the physical environment, the culture, and the society in which they live.
- 2.3.3 Students receiving an Associate degree must satisfactorily complete twenty-~~one~~ four (24~~1~~) units in general education selected from the following areas as indicated:

2.3.3.1 Natural Sciences (three [3] units minimum)

Courses in the natural sciences ~~are those which~~ examine the physical universe, its life forms and its natural phenomena. ~~To satisfy the general education requirement in natural sciences, a course should,~~ helping students ~~develop an appreciation and understanding of~~ appreciate and understand the scientific method, ~~and encourage an understanding of~~ and the relationships between science and other human activities. This category includes introductory or integrative baccalaureate-level courses in astronomy, biology, chemistry, general physical science, geology, meteorology, oceanography, physical geography, physical anthropology, physics and other scientific disciplines.

2.3.3.2 Social and Behavioral Sciences (three [3] units minimum)

Courses in the social and behavioral sciences focus ~~are those which focus~~ on people as members of society. ~~To satisfy the general education requirement in social and behavioral sciences, a course should help the student~~ and develop ~~an~~ awareness of the method of inquiry used by the social and behavioral sciences. ~~They It should~~ stimulate critical thinking about the ways people act and have acted in response to their societies and ~~should~~ promote appreciation of how societies and social subgroups operate. This category includes introductory or integrative baccalaureate-level survey courses in cultural anthropology, cultural geography, economics, history, political science, psychology, sociology and related disciplines, ~~exclusive of those which fulfill the American Institutions requirement.~~

~~2.3.3.3 American Institutions Requirement (three [3] units minimum)~~

~~Courses in American Institutions are those which focus on the historical development of American institutions and ideals, the~~

~~operation of representative democratic government under the Constitution of the United States, and the principles of state and local government established under the Constitution of this State. To satisfy the general education requirement in American Institutions, a course should help the student develop an appreciation and understanding of the basic institutions, ideals, knowledge, and skills necessary for intelligent and loyal citizenship. It should stimulate critical thinking, problem solving, and literacy skills in regard to American historical, political, governmental, economic, social, and intellectual issues as they relate to both domestic and foreign affairs. This category includes introductory or integrative survey courses in history and political science which qualify under the guidelines of either “a” or “b” below.~~

~~(a) — Any course which addresses the historical development of American Institutions and ideals, inclusive of the following:~~

- ~~1. — Significant events occurring in the entire area now included in the United States of America, including the relationships of regions within that area and with external regions and powers as appropriate to the understanding of those events within the United States during the period under study.~~
- ~~2. — The role of major ethnic and social groups in such events and the contexts in which the events have occurred.~~
- ~~3. — The events presented within a framework which illustrates the continuity of the American experience and its derivation from other cultures including consideration of three or more of the following: politics, economics, social movements, and geography.~~

~~(b) — Any course which addresses the U.S. Constitution, representative democratic government operation, and the process of California State and local government, inclusive of the following:~~

- ~~1. — The political philosophies of the framers of the Constitution and the nature and operation of United States political institutions and processes under that Constitution as amended and interpreted.~~
- ~~2. — The rights and obligations of citizens in the political system established under the Constitution.~~
- ~~3. — The Constitution of the State of California within the framework of evolution of Federal State relations and the nature and processes of State and local government under that Constitution.~~

~~4. Contemporary relationships of State and local government with the Federal government, the resolution of conflicts and the establishment of cooperative processes under the constitutions of both the State and nation, and the political processes involved.~~

~~2.3.3.4~~ 2.3.3.3 Arts and Humanities (three [3] units minimum)

Courses in the humanities ~~are those which~~ study the cultural activities and artistic expressions of human beings. ~~To satisfy the general education requirement in the humanities, a course should help the student develop~~ Such courses develop students' an awareness of ~~the ways in which~~ how people throughout the ages and in different cultures ~~have responded~~ to themselves and the world around them in artistic and cultural creation and ~~help the student develop~~ students' an aesthetic understandings and ~~an abilities~~ to make value judgments. This category includes introductory or integrative baccalaureate-level courses in the visual and performing arts, art history, foreign languages, literature, philosophy, religion, and related disciplines.

~~2.3.3.5~~ 2.3.3.4 English Composition, Oral Communication and Critical Thinking ~~Languages and Rationality~~ (six [6] units: three [3] units each from (a) and (b))

Courses in English composition, oral communication and critical thinking in language and rationality ~~are those which use and examine principles and guidelines of clear and logical thinking and communication.~~ Courses in this category should build upon rather than remediate verbal and quantitative skills.

- (a) English Composition. Courses fulfilling ~~the written composition~~ this requirement must be baccalaureate-level and should include ~~both~~ expository and argumentative writing.
- (b) Oral Communication and ~~Analytical~~ Critical Thinking. Courses fulfilling ~~the communication and analytical thinking~~ this requirement ~~include~~ must be baccalaureate level and include oral communication and critical thinking courses. ~~written communication, mathematics, logic, statistics, computer language and programming, and related disciplines.~~ Critical thinking courses develop an awareness of the relationship of language to logic, resulting in the ability to analyze, criticize, and advocate ideas, to reason inductively and deductively, and to identify the assumptions upon which particular conclusions depend.

~~2.3.3.6~~ 2.3.3.5 Living Skills (three [3] units minimum)

One physical education activity course (with ADAPT, DANCE, FITNS, PACT, SPORT, or TMACT designators) must be taken in this area and a minimum of two (2) units from the other courses included in this category. Adapted physical education courses are available for students with documented physical disabilities. These Adapted courses will fulfill the graduation requirement.

Courses in this area may be selected from a number of different disciplines that help students to acquire skills and knowledge to understand themselves as whole persons (integral to their environment). This category includes the study of courses that develop and maintain personal, social, physical and emotional well-being. It is the intent that this area include such courses as health education, human sexuality, marriage and family, nutrition, and personal adjustment.

~~2.3.3.6.1~~ 2.3.3.5.1 Students with medical excuses may petition to be exempted from the physical activity course requirement when appropriate adapted physical education classes are not offered at the location where the student takes the majority of their course work.

Students not completing a physical activity course on the basis of this exemption shall be required to complete a minimum of three (3) units in other courses in the Living Skills area.

~~2.0.1.1.1~~ 2.3.3.5.2 Students in majors with four-five (45) units or more of required coursework are exempted from the Living Skills requirement. Each college shall set up a process to apply this exemption.

2.3.3.6 Mathematical Concepts and Quantitative Reasoning (three [3] units minimum)

Courses in mathematical concepts and quantitative reasoning develop students' abilities to draw conclusions from numerical information, use formal reasoning processes, practice computational skills, and apply mathematical concepts or formal reasoning to solve real-world problems. Courses fulfilling this requirement must be at least college-level and include mathematics and quantitative reasoning courses, including logic, statistics, computer programming languages, and related disciplines.

2.3.3.7 Ethnic Studies (three [3] units minimum)

Courses in ethnic studies must be baccalaureate level and include courses in the four autonomous disciplines within Ethnic Studies or introductory courses which survey the four areas: (1) Black Studies, African American Studies, Africana Studies, (2) Native American Studies, (3) Chicano/a/x, Latino/a/x Studies/La Raza Studies, and (4) Asian American Studies.

2.3.4 While a course might satisfy more than one (1) general education requirement, it may not be counted more than once for these purposes. Courses which are a part of the major requirement and meet the intent of these general education guidelines may be used to satisfy both requirements.

~~2.3.5 Ethnic studies will be offered in at least one (1) of the required general education areas (2.3.3.1-2.3.3.5).~~

~~2.3.6~~ 2.3.5 Each College shall set up a process that will involve the review of courses submitted to meet the objectives and criteria of general education.

~~2.3.6~~ Students who show proof of a baccalaureate or higher degree completed at a college or university accredited through a CHEA (Council for Higher Education Accreditation) recognized Regional Accrediting Agency will have satisfied general education, Ethnic/Multicultural studies, and competency requirements for the Associate in Arts or the Associate in Science degree. Students who have been awarded a bachelor's degree from an institutionally accredited institution shall be deemed to have fulfilled the general education course requirements for the Associate in Arts or the Associate in Science degree. Degrees from accredited institutions outside of the United States will be evaluated on a case-by-case basis. ~~All Associate degrees from institutions accredited from CHEA Regional Accrediting Agencies will be evaluated on a case-by-case basis.~~ Degrees or courses from non-accredited institutions will not be considered.

2.3.7 Students who have completed the requirements for the Cal-GETC lower-division general education pattern will have satisfied the general education requirements for the Associate in Arts or the Associate in Science degree.

~~2.4 Basic Skills Competencies~~

~~2.4.1 All students granted an Associate in Arts or Associate in Science degree shall have demonstrated college-level competence in reading, written expression, and mathematics.~~

~~2.4.1.1 Examinations used to assess competency in any one of these areas will be uniform throughout the District and will be recommended~~

~~by committees composed of members as provided in District Regulation (R-3412).~~

~~2.4.1.2 The Chancellor shall adopt Administrative Regulations establishing specific competency standards.~~

~~2.5—Ethnic/Multicultural Studies~~

~~2.5.1 One (1) three (3) unit Ethnic/Multicultural studies course must be completed within the sixty (60) unit graduation requirement. The course may be completed as part of the twenty-one (21) unit general education pattern, as a course required by the major, or an elective course.~~

~~2.5.1.1 Courses in Ethnic/Multicultural studies examine significant aspects of the culture, contributions and social experiences of underrepresented ethnic/racial groups in the U.S., or the history and cultural traditions of non-western societies. Non-western courses should focus on non-Eurocentric cultures.~~

~~2.5.1.2 All courses should be comparative among multiple social groups and should include analysis of concepts of ethnicity, ethnocentrism and racism, and how they shape and explain ethnic experience.~~

3.0 Credit by Examination

3.1 Any specific course requirement may be satisfied by the procedures established for credit by examination.

4.0 Transfer Graduation Requirements (SB 1440):

4.1 For curricula approved pursuant to SB 1440 (2010) by the Board of Trustees (approved curriculum), the graduation requirements for the Associate in Arts for Transfer and Associate in Science for Transfer degrees shall consist entirely of the following requirements which also satisfy all basic skills competency requirements:

4.1.1 Successful completion of sixty (60) semester units eligible for transfer to the California State University, which shall include satisfaction of the following two (2) requirements:

4.1.1.1 Completion of one (1) or the following General Education Patterns:

4.1.1.1.1 The Intersegmental General Education Transfer Curriculum (IGETC), [effective for students enrolled prior to Fall 2025](#); or

[4.1.1.1.2](#) The California State University General Education-Breadth Requirements, [effective for students enrolled prior to Fall 2025](#); or

[4.1.1.1.3 The California General Education Transfer Curriculum \(Cal-GETC\), effective for students enrolled on or after Fall 2025.](#)

4.1.1.2 Completion of at least eighteen (18) semester units in a major or area of emphasis identified in the approved curriculum

4.1.2 A minimum grade point average of 2.0.

5.0 Courses Specified

5.1 Each College within the District shall specify in its College catalog the courses that may be taken by a student in each of the required areas listed above. Requirements satisfied at one College will be accepted by any other College within the District.



BACKGROUND:

With the passage of Assembly Bill 102, California community college districts are authorized to enter into a College and Career Access Pathways Partnership with a charter school to expand opportunities for high school students to take college courses during the regular school day and for community colleges to claim apportionment. To go forward with this program, the law requires community college districts and charter schools to enter into a Memorandum of Understanding approved by the governing boards of both the community college district and the charter school.

STATUS:

The proposed College and Career Access Pathways (CCAP) Memorandum of Understanding (MOU) is between the Los Rios Community College District and Rex & Margaret Fortune Early College High School. There are no significant differences between this MOU and our standard CCAP MOU template. This MOU will replace the current non-CCAP MOU that expires in June of 2025. The purpose of the MOU is to offer and expand dual enrollment opportunities for students who may not already be college bound or who are underrepresented in higher education, with the goal of developing seamless pathways from high school to community college. Beginning Spring 2025, classes will be offered to High School students attending Rex & Margaret Fortune Early College High School. At the completion of these classes, students will earn credit toward multiple degree or certificate programs within their relevant college’s catalog.

RECOMMENDATION:

It is recommended that the Board of Trustees conduct a public hearing; adopt the proposed CCAP MOU between the Los Rios Community College District and Rex & Margaret Fortune Early College High School and authorize the Chancellor or his designee(s) to execute the MOU and any future augmentations, amendments, renewals, extensions, or other modifications to the MOU.

**Memorandum of Understanding
Regarding Dual Enrollment
Between the Los Rios Community College District
and
Rex & Margaret Fortune Early College High School**

This Memorandum of Understanding (“MOU”) is by and between the Los Rios Community College District and its respective colleges (“LRCCD”), and Rex & Margaret Fortune Early College High School (“CHARTER”).

RECITALS

WHEREAS, LRCCD is a multi-college District whose mission includes providing educational programs and services that are responsive to the needs of the students and communities within the CHARTER;

WHEREAS, CHARTER is a charter school located in Sacramento County and authorized by the Sacramento County Office of Education;

WHEREAS, the parties desire to enter into a College and Career Access Pathways (“CCAP”) partnership to collaborate and provide college credit and courses pursuant to Assembly Bill 288;

WHEREAS, the purpose of this MOU is to offer and expand dual enrollment opportunities for students who may not already be college-bound or who are underrepresented in higher education, with the goal of developing seamless pathways from high school to community college for career technical education or preparation for transfer, improving high school graduation rates, or helping high school pupils achieve college and career readiness;

WHEREAS, instruction will comply with the student selection standards, curriculum guidelines, recommendations and procedures promulgated by the Legislature and LRCCD;

WHEREAS, the parties desire to enter into a MOU, which sets forth their mutual rights and responsibilities and governs their relationship;

WHEREAS, this MOU contemplates that the parties will enter into a related Course Agreement (“CA”) for the individual Courses (“Courses”) offered under this MOU, that each CA will fully incorporate the terms of this MOU, and that each CA will set out the necessary details specific to the subject Programs/Courses;

WHEREAS, the parties intend for LRCCD to report full-time equivalent students (“FTES”) and obtain state apportionment for the subject Courses given through this MOU in accordance with California Education Code, section 76004 and the appropriate portions of Title 5 of the California Code of Regulations;

WHEREAS, all Courses will be held within LRCCD's District boundaries unless an agreement exists or is established between LRCCD and another community college district authorizing the CCAP partnership outside of LRCCD boundaries in accordance with California Education Code section 76004(e), in which case the letter of authorization will be attached at the end of this agreement;

WHEREAS, this dual enrollment agreement has been approved by the Board of CHARTER on October 17, 2024 and the Board of LRCCD on November 13, 2024;

NOW, THEREFORE, the parties mutually agree as follows:

TERMS

1. **Recitals**. The above recitals are incorporated herein and made a part of this MOU.
2. **Effective Date and Duration**. This MOU shall be effective following its approval by the governing board of each party and on the date authorized representatives of both parties sign it. This MOU renews automatically on an annual basis, until either party indicates a desire to change or discontinue the MOU.
3. **Early Termination**. This MOU may be terminated by either party with cause if another party fails to comply with the insurance or indemnification requirements or otherwise commits a material breach. Termination will be effective no sooner than 15 calendar days after a written demand to cure is provided and the party fails to cure. This remedy is in addition to any other remedy which may be provided for by law.

This MOU may be terminated without cause and for any reason by any party. The party desiring early termination without cause must provide written notice to the other parties. Termination will be effective no sooner than 60 calendar days after actual receipt of the written notice. Any students currently enrolled in LRCCD Courses under this MOU shall be allowed to complete those Courses prior to the termination of this MOU.

The indemnification provisions contained in this MOU shall survive termination.

4. **Course Agreements**. The terms of this MOU are deemed to be part of and fully incorporated into any and all presently existing or future CAs. Related CAs will typically address the scope, nature, time, date, location, number of educational hours, LRCCD credits offered, number of students, and other specifics related to each Course. The terms of an individual CA may differ from this MOU as necessary, including eligibility requirements for students to enroll in a particular course or courses. Any inconsistency between the MOU and an express provision of a CA will be resolved in favor of that particular CA, and will only be effective as to that particular CA.

5. Required Information.

- A. The total number of high school students to be served by this MOU is estimated at approximately 180 students per academic year.
- B. The total number of full time equivalent students (“FTES”) projected to be claimed by LRCCD for apportionment under this MOU will be calculated using the California Community College apportionment formula and will be determined based on the number of LRCCD units each student participant is enrolled in per academic year. The total number of FTES to be served by this MOU is estimated at approximately 100 students per academic year.
- C. The criteria to assess the ability of pupils to benefit from those Courses is as follows:
 - i. Students will complete the College’s Dual Enrollment Application Process for Participation which may include:
 - a. Enrollment in a Prerequisite Course if required
 - b. Recommendation and/or requirement to enroll in an entry level college course prior to participation in other general education courses
- D. The point of contact for LRCCD is Deputy Chancellor Jamey Nye. The point of contact for CHARTER is Dr. Margaret Fortune, President/CEO at Rex & Margaret Fortune Early College High School.
- E. All sharing of information between LRCCD and the CHARTER shall be in compliance with Federal Educational Rights and Privacy Act (“FERPA”) and California law. Where exceptions to those laws allow LRCCD and the CHARTER to share information without the consent of the students, LRCCD and the CHARTER will follow the requirements of FERPA and California law. No data shall be shared by either party until the other party is satisfied, in its sole discretion, as to the safety and security of that data in the other party’s control. Where there is no exception to share student data, a signed, dated release from the student (or parent or legal guardian of a minor student) explicitly authorizing the sharing of personally identifiable information about the student will be required.
- F. LRCCD and CHARTER shall not utilize Joint Use Facilities. Instruction shall occur on the CHARTER campuses, LRCCD campuses and/or in online spaces hosted by LRCCD.
- G. Parents or legal guardians shall be required to sign a form consenting to the enrollment of their pupils in community college Courses offered by LRCCD. The consent form shall be submitted to and be maintained by LRCCD. Pursuant to LRCCD Policy and Regulation, LRCCD data concerning a student shall not be shared with parents without a signed, dated release from the student authorizing the sharing of that data.

H. LRCCD shall be the employer of record for purposes of assignment monitoring and reporting to the County Office of Education if required and shall assume reporting responsibilities pursuant to applicable federal teacher quality mandates. (Ed. Code § 76004(m)) Copies of documents provided to the county office of education shall be provided to the DISTRICT and LRCCD.

6. Required Certifications.

- A. The Board of Trustees of LRCCD and CHARTER will pass a resolution approving this MOU as required under Education Code section 76004.
- B. All college Course faculty will be employees of LRCCD.
- C. Individuals selected by LRCCD to teach courses shall not have been convicted of sex offenses, controlled substance offenses, serious felonies, or violent felonies, as defined in the Education Code.
- D. LRCCD faculty teaching a Course at a CHARTER campus shall not displace or cause the termination of an existing CHARTER teacher teaching the same course on the CHARTER campus.
- E. CHARTER teachers teaching a Course offered for college credit at a CHARTER school will not displace or cause the termination of an existing LRCCD faculty teaching the same Course at LRCCD.
- F. Community college Courses offered for college credit at the CHARTER campus will not reduce access to the same Courses offered at LRCCD colleges.
- G. Any LRCCD community college Course that is oversubscribed or has a waiting list at LRCCD will not be offered within the partnership.
- H. Participation in the partnership is consistent with the core mission of the community colleges pursuant to Education Code, section 66010.4.
- I. High school students participating in the partnership will not lead to the enrollment displacement of otherwise eligible adults at LRCCD colleges.
- J. LRCCD will comply with local collective bargaining requirements to the extent they apply, and both Parties will comply with all state and federal reporting requirements.
- K. Any pretransfer-level course taught by LRCCD faculty (which includes a qualified high school teacher teaching a college course as an "employee" of the community college district pursuant to CCR, Title 5 Section 58058(b)) at a CHARTER high school campus shall be offered only to high school

students who do not meet their grade level standard in math, English, or both based on an interim assessment in grade 10 or 11, as determined by the CHARTER, and that the delivery of these remedial courses shall involve a collaborative effort between the CHARTER high school and LRCCD faculty to deliver an innovative remediation course as an intervention in the student's junior or senior year to ensure the student is prepared for college-level work upon high school graduation. (Ed. Code § 76004(n))

7. Regulatory Requirements for State Apportionment Purposes Applicable to All Courses Conducted Under the Terms of This MOU. These provisions may

not be voided, modified nor waived by a related CA unless otherwise expressly provided herein:

- A. Responsibilities of Each Party. LRCCD Board Policies, Administrative Regulations, and procedures apply to the Course and to the students enrolled in those Courses and LRCCD is responsible for the Courses. The Courses will comply with all applicable regulations, procedures, prerequisites and standards applicable to LRCCD, as well as any corresponding local policies, practices, and requirements of the CHARTER. This MOU is subject to existing CHARTER Board Policy on Dual Enrollment.
- B. Enrollment Period. The enrollment period shall be determined by LRCCD in accordance with its guidelines, policies, pertinent statutes, and regulations.
- C. Number of Course Hours Sufficient to Meet the Stated Performance Objectives. LRCCD will determine the student learning outcomes for each of the Courses and the number of course hours necessary to meet the performance objectives. The performance objectives and corresponding course hours shall be specified in the related CA.
- D. Supervision and Evaluation of Students. Supervision and evaluation of students shall be in accordance with LRCCD guidelines, Board Policies, Administrative Regulations, pertinent statutes, and regulations. During class time, all students will be under the immediate supervision of an employee of LRCCD. Where a health or safety emergency arises at a class, the school overseeing the course location will be responsible for taking the lead to deal with the health and safety issue and ensure the safety of the school, its staff, and students. Discipline for actions taken during College Courses will be pursuant to the LRCCD Board Policies and Administrative Regulations. For purposes of this paragraph all CHARTER employees who are teaching the Courses shall be deemed to be employees of LRCCD. The school overseeing the course location shall be responsible for all Americans with Disabilities Act ("ADA") and Individual Education Plan issues for its students; LRCCD shall be responsible for any academic accommodations deemed necessary through the LRCCD DSPS program.

- E. Withdrawal Prior to Completion of the Course. A student's withdrawal prior to completion of the Course shall be in accordance with LRCCD guidelines, policies, pertinent statutes and regulations.
- F. Right to Control and Direct Instructional Activities. LRCCD is responsible for the Courses and has the sole right to control and direct the instructional activities of all faculty teaching those Courses, including those who are also CHARTER personnel.
- G. Minimum Qualifications for Faculty Teaching Courses. All faculty that teach Courses shall meet the minimum qualifications to provide instruction in a California community college.
- H. Criminal Background Checks. LRCCD shall ensure that personnel who may come into contact with students have a valid criminal records clearance as required by Education Code section 45125.1. Alternatively, LRCCD personnel without such clearance shall not have access to students or CHARTER's campus. LRCCD shall affirm to CHARTER annually that it is in compliance with Education Code section 45125.1.
- I. Facilities. CHARTER will provide adequate classroom space at its facilities, or other mutually agreed upon location, to conduct the contemplated instruction and do so without charge to LRCCD or students. CHARTER agrees to clean, maintain, and safeguard CHARTER's premises. CHARTER warrants that its facilities are safe and compliant with all applicable building, fire, and safety codes.
- J. Equipment. CHARTER will furnish, at its own expense, all course materials, specialized equipment, and other necessary equipment for all CHARTER students. The parties understand that such equipment and materials are CHARTER's sole property. The faculty shall determine the type, make, and model of all equipment and materials to be used during each Course. CHARTER understands that no equipment or materials fee may be charged to students. Students in a Course who are not enrolled in CHARTER shall be provided course materials, specialized equipment, and other necessary equipment as specified in LRCCD Policies.
- K. Enrollment. Enrollment shall be open to any CHARTER pupil who has been admitted to LRCCD and meets all applicable prerequisites. Applicable prerequisite courses, training, or experience will be determined by LRCCD. Applicants must meet the standards and prerequisites of the LRCCD.

LRCCD will be responsible for processing student applications. LRCCD will provide the necessary admission forms and procedures and both LRCCD and CHARTER will jointly ensure that each applicant accepted has met all

the enrollment requirements, including liability and medical care coverage requirements, if any.

LRCCD will ensure that each student completes the admissions procedure, the course enrollment process, and otherwise process student applications and enroll students in the Courses, as appropriate. CHARTER will assist LRCCD as necessary. A successful enrollment requires that each student has completed an enrollment application provided by LRCCD, completed the parental permission form, the application and parental permission form has been delivered to and accepted by LRCCD's Admissions and Registration Office, all enrollment and other applicable fees have been paid, and the applicant has met all requirements, to include the standard LRCCD student liability and medical care coverage, if applicable.

- L. Enrollment Fees. Pursuant to LRCCD Board Policy, Education Code sections 76300(f), and 76004, students enrolled in Courses under this MOU shall be exempt from fees described in Education Code sections 76060.5 (student body fee), 76140 (nonresident tuition), 76223 (copies of records), 76300 (student fee), 76350 (apprenticeship fees), and 79121 (child development center fees). Students enrolled in these Courses will pay all other applicable fees (i.e. Universal Transit Fee, or other fees, etc.).
 - M. Records of Student Attendance and Achievement. All records of student attendance and achievement shall be submitted to LRCCD periodically, or upon demand, and shall be maintained by LRCCD.
 - N. Ancillary Support Services for Students. Both LRCCD and CHARTER shall ensure that students enrolled in the Courses are provided ancillary and support services as may be needed, including but not limited to counseling and guidance and placement assistance.
8. **Liaison.** At no cost to the CHARTER, LRCCD will provide the services of faculty members who will facilitate coordination and cooperation between LRCCD and CHARTER. LRCCD will provide CHARTER personnel with reasonable assistance, direction and instruction in how to fulfill their responsibilities under this MOU, including conducting appropriate student assessments, outreach/recruitment activities and the LRCCD's application procedures.
9. **Support Staff.** These provisions may not be voided, modified nor waived by a related CA unless otherwise expressly provided herein:
- A. CHARTER to Provide Support Services. Unless otherwise provided for in a related CA, CHARTER will provide personnel to perform the following services on its campus: clerical services and services associated with outreach activities, recruiting students, assessing students, processing student applications, enrolling qualified students, and other related services as may be necessary.

- B. CHARTER is Responsible for its Own Personnel. CHARTER's personnel will perform these services on duty time. CHARTER personnel performing these services will be employees solely of CHARTER, subject to the authority of CHARTER, but will also be subject to the direction of LRCCD, specifically with regard to their duties pertaining to the Courses described in the related CAs. LRCCD has the primary right to control and direct Course activities.

10. Faculty. These provisions may not be voided, modified nor waived by a related CA unless otherwise expressly provided herein:

- A. LRCCD to Select and Employ Faculty. LRCCD will select faculty pursuant to its own policies, regulations and the law. CHARTER personnel selected to be faculty shall be employees solely of LRCCD during the time they teach LRCCD courses, but will also be subject to the authority of CHARTER, specifically with regard to their duties as CHARTER employees. The LRCCD faculty shall be subject to the LRCCD Collective Bargaining Agreement with the Los Rios College Federation of Teachers in effect at the time the Course is offered.
- B. Faculty. LRCCD shall ensure that all faculty are experienced, competent, dedicated personnel who have the personal attributes necessary for providing instruction in the Courses. LRCCD shall ensure that all faculty possess all minimum qualifications, any certificates or other training requirements that may be required including, but not limited to the qualification requirements of Title 5 CCR 53410 and 58060.
- C. LRCCD Shall Determine Faculty Requirements. LRCCD shall determine the number of faculty, the ratio of faculty to students, and the subject areas of instruction.
- D. Orientation Meeting. Faculty shall attend an orientation meeting if scheduled and LRCCD shall provide manuals, course outlines, curriculum materials, and testing and grading procedures as necessary.

11. Instruction. All lectures will conform to LRCCD approved curriculum and course outlines and recommendations of experienced LRCCD faculty. All Courses must follow LRCCD's required hours of instruction and meet LRCCD's minimum enrollment requirements. Instructional presentations will incorporate planned practical demonstrations, as may be necessary, and use audiovisual techniques or equipment and vocational equipment.

12. Facilities. The parties contemplate that primarily, the facilities of the CHARTER will be utilized to carry out the goals of this MOU and any related CA, although from time to time LRCCD facilities may be utilized subject to mutual MOU by the parties as expressed in a related CA. The Parties agree to defend, hold harmless,

and indemnify the other and its governing board, officers, employees, administrators, independent contractors, subcontractors, and other representatives from all damages, losses, or expenses, including litigation costs such as attorney's fees, should a student, faculty, or third party be injured as a result of or connected with the condition of the Party's premises, in whole or in part, for a Course taught on that Party's campus. The indemnity shall survive termination of this MOU and is in addition to any other rights or remedies the Parties may have under law or otherwise.

13. Workers' Compensation. Each party shall be the "primary employer" for all its personnel who perform services as support staff. Each party shall be solely responsible for processing, investigating, defending, and paying all workers' compensation claims by their respective personnel made in connection with performing services and receiving instruction under this MOU or any related CA. Each party agrees to hold harmless, indemnify, and defend the other from any liability resulting from its failure to process, investigate, defend, or pay any workers' compensation claims by the Party's employees who are connected with providing services under this MOU or any related CA. Neither Party is responsible for the personal injury of the personnel of the other Party who may serve as faculty, or students who are not affiliated with this partnership. These provisions may not be voided, modified nor waived by a related CA.

14. Reporting Requirements. Annually, LRCCD and CHARTER shall report all of the following information to the office of the Chancellor of the California Community Colleges:

- A. The total number of high school pupils by school-site enrolled in each partnership, aggregated by gender and ethnicity, and reported in compliance with all applicable state and federal privacy laws.
- B. The total number of community college Courses by course category and type and by school-site enrolled in by partnership participants.
- C. The total number and percentage of successful Course completions, by course category and type and by school-site, of partnership participants.
- D. The total number of full-time equivalent students generated by CCAP partnership community college district participants.

Copies of the same information will be made available to the CHARTER Board of Directors upon request.

15. Indemnification.

- A. CHARTER shall defend, hold harmless, and indemnify LRCCD, its governing board, officers, administrators, agents, employees, independent contractors, subcontractors, consultants, and other representatives from

and against any and all liabilities, claims, demands, costs, losses, damages, or expenses, including reasonable attorney fees and costs, including but not limited to consequential damages, death, sickness, or injury to any person(s) or damage to any property, from any cause whatsoever arising from or connected with the provision of instruction pursuant to this MOU or any related CA that may arise out of or result from, in whole or in part, the negligent, wrongful, or willful acts or omissions of CHARTER, its employees, agents, subcontractors, independent contractors, consultants, or other representatives.

- B. LRCCD shall defend, hold harmless, and indemnify CHARTER, their governing board, officers, administrators, agents, employees, independent contractors, subcontractors, consultants, and other representatives from and against any and all liabilities, claims, demands, costs, losses, damages, or expenses, including reasonable attorney fees and costs, including but not limited to consequential damages, death, sickness, or injury to any person(s) or damage to any property, from any cause whatsoever arising from or connected with its responsibilities hereunder that may arise out of or result from, in whole or in part, the negligent, wrongful, or willful acts or omissions of LRCCD, its employees, agents, subcontractors, independent contractors, consultants, or other representatives.
- C. CHARTER shall have no obligation to defend, hold harmless, or indemnify LRCCD, its governing board, officers, administrators, agents, employees, independent contractors, subcontractors, consultants, and/or other representatives for their sole negligence or willful misconduct; and LRCCD shall have no obligation to defend, hold harmless, or indemnify CHARTER, its governing board, officers, administrators, agents, employees, independent contractors, subcontractors, consultants, and/or other representatives for their sole negligence or willful misconduct.
- D. This indemnity shall survive termination of this MOU or any related CA, and is in addition to any other rights or remedies that CHARTER or LRCCD may have under law and/or otherwise.
- E. These provisions may not be voided, modified nor waived by any related CA.

16. Insurance Requirements.

- A. During the entire term of this Agreement, each party shall, at its own expense, maintain, and shall require all subcontractors associated with this agreement to maintain insurance as set forth below and shall provide the additional insured endorsements that name the other party as an additional insured on the each party's General Liability policy and Automobile Liability policy. Minimum Scope of Insurance: Coverage shall be:

- i. Commercial General Liability. \$1,000,000 combined single limit per occurrence for bodily injury, personal injury and property damage; and a \$3,000,000 aggregate. Any combination of General Liability, and Excess Coverage amounting to a minimum of \$3,000,000 in coverage will be acceptable. The Commercial General Liability additional insured endorsement shall be as broad as the Insurance Services Inc.'s (ISO) additional insured, Form B CG 20101001.
 - ii. Automobile Liability. "Any Auto" with \$1,000,000 combined single limit per accident for bodily injury and property damage.
 - iii. Workers' Compensation. As required by the Labor Code of the State of California, and Employers' Liability Insurance; with limits as required by the Labor Code of the State of California and Employers' Liability limits of \$1,000,000 per accident.
- B. If the above insurance is written on a claims-made form, it shall have a retroactive date of placement prior to or coinciding with the effective date of this Agreement and continue for at least three full years following the completion of any services/work under this Agreement. Any deductibles, self-insured retentions, or changes in these items must be declared to and approved by the other party. Each party's insurer shall agree to waive all right of subrogation against the other, its trustees, officers, and agents for losses arising from the work performed. Each insurance policy shall include the standard Severability of Interest, or Separation of Insured (General Liability Form CG 00 01 12 04) clause in the policy and when applicable the cross liability insurance coverage provision which specifies the inclusion of more than one insured shall not operate to impair the rights of one insured against another insured. Each insurance policy required by this Agreement shall be endorsed to state that coverages shall not be canceled except after thirty (30) days prior written notice has been given to the other party. Each party shall provide the other with certificates of insurance and required executed endorsements, evidencing compliance with this section, prior to the commencement of any Courses. On request, each party shall furnish copies of any and/or all of the required insurance policies.
- C. Nothing in this section concerning minimum insurance requirements shall reduce a party's liability or obligations under the indemnification provisions of this MOU.
- D. The parties acknowledge that both parties are permissibly self-insured under California law.
- E. These provisions may not be voided, modified nor waived by a related CA.

17. Discrimination and Harassment. Each party agrees it will not unlawfully discriminate, harass, or allow harassment against any employee or other person

because of ethnic group identification, race, color, sex, gender, gender identity, gender expression, pregnancy or childbirth-related condition, sexual orientation, sexual identity, religion or religious creed, age (over forty), national origin, ancestry, physical or mental disability, medical condition, political affiliation or belief, military and veteran status, or marital status, and shall comply with all applicable laws pertaining to employment.

18. Parties Not Co-Employers

LRCCD and CHARTER maintain separate staff. A joint employer or joint venture relationship does not exist between the Parties. The Parties agree as follows:

- (a) Each Party has the sole right to control and direct the means, manner and method by which their employees perform their duties.
- (c) Each Party has the right to hire employees or contractors to provide the services required by this MOU.
- (d) The employees and contractors utilized by each Party do not gain employment, rights, benefits, insurance, tenure, or compensation from the other Party.

19. Entire Agreement. This MOU and any related CAs constitute the entire agreement between the parties with regard to the Courses and supersedes any prior or contemporaneous understanding or agreement. No party has been induced to enter into this MOU by, nor is any party relying on, any representation or promise outside those expressly set forth in this MOU and any related CA.

20. Amendment. The provisions of this MOU may be modified only by mutual MOU of the parties. No modification shall be binding unless it is in writing and signed by the party against whom enforcement of the modification is sought.

21. Waiver. Unless otherwise precluded by the terms of this MOU, terms or conditions may be waived by the party entitled to the benefit of the term or condition, but no such waiver shall affect or impair the right of the waiving party to require observance, performance, or satisfaction of that term or condition as it applies on a subsequent occasion.

22. Assignment. Neither party may assign any rights or benefits or delegate any duty under this MOU without written consent of the other party. Any purported assignment without written consent shall be void.

23. Parties in Interest. Nothing in this MOU, whether express or implied, is intended to confer any rights or remedies under or by reason of this MOU on any person other than the parties to it and their respective successors and assigns, nor is

anything in this MOU intended to relieve or discharge the obligation or liability of any third person to any party to this MOU, nor shall any provision give any third person any right to subrogation or action against any party to this MOU.

24. Severability. If any provision of this MOU is held by an arbitrator or court of competent jurisdiction to be invalid or unenforceable, the remainder of the MOU shall continue in full force and effect and shall in no way be impaired or invalidated.

25. Notices. Any notice under this MOU shall be in writing, and any written notice or other document shall be deemed to have been duly given on the date of personal service on the parties or on the second business day after mailing if the document is mailed by registered or certified mail, addressed to the parties at the addresses set forth below, or at the most recent address specified by the addressee through written notice under this provision. Failure to conform to the requirement that mailings be done by registered or certified mail shall not defeat the effectiveness of notice actually received by the addressee.

26. Authority to Enter Into MOU. Each party to this MOU represents and warrants that it has the full power and authority to enter into this MOU and to carry out the transactions contemplated by it and that it has taken all action necessary to authorize the execution, delivery, and performance of this MOU.

27. Status of the Parties. Neither party is a partner, joint venture, co-principal, employer, or co-employer of the other or of an employee of the other party. The Parties are solely responsible for paying all salaries, wages, benefits, and other compensation which its employees or subcontractors may be entitled to receive in connection with performing services under this MOU and any related CA. The Parties shall be solely responsible for withholding and paying all applicable payroll taxes and contributions, including federal, state, and local income taxes, FICA, FUTA, and state unemployment, workers' compensation, and disability insurance for their respective employees in connection with performing services under this MOU and any related CA.

28. Retention and Audit of Records. Each party shall maintain records pertaining to this MOU and related CAs as may be required by federal and state law. Each party may review and obtain a copy of the other party's pertinent records subject to federal and state privacy statutes.

29. Governing Law and Venue. This MOU will be governed by and construed in accordance with California law and venue of any action or proceeding in connection with this MOU shall be Sacramento County, California.

COURSE AGREEMENT

This course agreement is entered into between the Los Rios Community College District (“LRCCD”) and Rex & Margaret Fortune Early College High School (“CHARTER”) regarding dual enrollment courses to be taught at the locations listed below.

1. The memorandum of understanding (“MOU”) entered into by LRCCD and CHARTER is incorporated by reference as if fully set forth herein. In the event of a conflict between the terms of this course agreement and the MOU, the terms of the MOU shall govern.
2. The approved curriculum and course outlines applicable to these courses are available online at the LRCCD website: <https://losrios.edu/academics>.
3. CHARTER students may be added to a section from any course listed below in combination with other dual enrolled high school students provided those likewise recognized CCAP districts or charter schools possess an MOU and agreement through LRCCD AND pending availability of an open seat.
4. The high school(s) served by this agreement include: Rex & Margaret Fortune Early College High School
5. The seamless pathways from school to college for this agreement include:
 - Career Technical Education
 - Preparation for Transfer
 - College and Career Readiness
 - Improving High School Graduation Rate
6. The Vision 2030 Goals that align with this agreement are:
 - Goal 1: Equity in Success - Ensure the academic and career success of all Californians who are current and prospective California community college students.
 - Goal 2: Equity in Access - Broaden the opportunities for all Californians to participate in higher education by starting or continuing their higher education at a California community college.
 - Goal 3: Equity in Support - Partner with other systems, agencies, institutions and community-based organizations to provide students the academic, financial and social supports necessary to thrive by taking education opportunities and the accompanying support to Californians.
