SUBJECT: CCCT BOARD ELECTION — 2025

Pursuant to the CCCT Board Governing Policies, the election of members of the CCCT Board of the League will take place between March 10 and April 25. This year there are four (4) seats up for election, with three (3) incumbents running.

Each community college district governing board shall have one vote for each of the four seats on the CCCT Board. Only one vote may be cast for any nominee or write-in candidate. The four candidates who receive the most votes will serve a three-year term.

The 16 trustees who have been nominated for election to the board are listed on the enclosed sheet in the Secretary of State's random drawing order of January 3, 2025. Voting will be conducted via eBallot, thus no sample ballot is included. Voting instructions will be sent to governing board assistants closer to the start of the voting period. Candidates' statements and bios are also available in the public League BoardDocs CCCT library <u>here</u> where more information on the CCCT Board is also available.

Voting via eBallot must be completed **no later than April 25**. Results will be announced at the <u>Annual Trustees Conference in May.</u>
