

LRCFT report to the LRCCD Board of Trustees

Dec. 17, 2025

The LRCFT continues to prepare for negotiations with the district for early next year. In the past month, we held 8 in person and virtual negotiations forums with over 500 faculty. We submitted our sunshine list to the District and look forward to starting formal negotiations on January 23.

The LRCFT recently held our annual holiday party for all faculty union members. Over one hundred faculty and family members attended the event.

The LRCFT held internal elections for college union pres. at ARC. I want to congratulate EOPS counselor Art Jenkins who will continue as president for another two-year term. Rebecca Goodchild, librarian, will also start as union president at SCC. They join Teresa Aldredge (CRC) and Kalinda Jones (FLC) to begin two-year terms.

The LRCFT on MLK Jr. Day will participate in two marches along with students, faculty, and community members. We are also funding 20 students to attend an MLK Day breakfast celebration.

In addition to financial contributions provided last month to the Los Rios student food pantries, the LRCFT contributed to the SCLC's Operation X mas basket for local union members in financial need.

The LRCFT continues to assist faculty with information regarding public loan forgiveness and part-time faculty unemployment. Both the CFT and AFT provide programs in these areas to help faculty.

The LRCFT continues to work with CFT and community college unions statewide to plan the student March in March on March 12 at the Capitol. Local elected officials and student and union leaders

will speak at the event which promises to be one the largest student marches in recent memory.

The LRCFT continues to plan for CFT's statewide One Faculty Week scheduled for April to showcase the common employment interests of full and part time faculty.

The LRCFT and CFT are collaborating with other unions and FACCC in the next few months to gather 1.3 million signatures to renew and make permanent the current Millionaire's Tax that funds public education. This measure passed as Prop. 30 in 2012 and was renewed as Prop. 55 in 2016.

I want to publicly praise the students, faculty, and staff in SCC's air traffic control program. Recently, the program was featured prominently in local media for its important contributions in alleviating the impacts of the federal government shutdown.

I would also like to congratulate Napa Valley College Superintendent/Pres. Dr. Torence Powell on his new role as LRCCD Chancellor effective July 1. We look forward to working with Dr. Powell in the years to come.

In closing, I would like to acknowledge the unfortunate passing on December 1 of long-time Cosumnes River College nurse and LRCFT exec. board member Reona James. Reona worked as a nurse at CRC for thirty years and provided a guiding influence for our union during its early development. She was personally influential to many of us and convinced me to run for union president at CRC in 2010. Our exec. board has passed a resolution in her honor and I have submitted the resolution as part of my report. Reona will be dearly missed.
