Below is a list of highlighted activities, accomplishments and events at each of the colleges within the Los Rios District. This report is to be used as a guide for the Student Advisory Committee representative and the Student Trustee in providing the monthly LRCCD student report at the LRCCD Board of Trustee (BOT) meetings. Only the information on this report will be used. Not all areas need to be completed; rather, this is a guide on topics to consider. Approved/signed college reports are due to the Student Trustee one week prior to each scheduled BOT meeting. The Student Trustee in consultation with the SAC Advisor will compile these submissions for one comprehensive report which is due to District Advisor Dr. Rosario, the designated student speaker, and SAC Advisor by noon the Friday before the BOT meeting. Late submissions/unauthorized reports will not be presented at the BOT meeting.

Student led-activities (i.e. March in March, campus events, fundraisers):

- ARC: ARC has continued work on virtual club days with the website BoothCentral. In addition, internal presentations were given to leaders to provide more information on this year's Los Rios Lobby Day topic.
- CRC: CRC hosted a virtual Hawk Week in late January.
- FLC: FLC's Joint Budget Committee was assigned a Canvas Shell project that included having a Youtube Channel. In addition, Student Senate Secretary Allison Schiffmaier formed a GA Resolution for the statewide Student Senate General Assembly.
- SCC: Student Senate has been preparing for Lobby Day and General Assembly.

Senate and CAEB Accomplishments (i.e. surveys, engagement in campus and regional governance):

- ARC: ARC held their first Senate and CAEB meetings for the semester and appointed more students to the ASB Basic Needs Committee.
- CRC: CRC confirmed the appointment of Sabehaa Baqui as Student Senate Treasurer. In addition, CRC is working on changes to the ASCRC Constitution/Bylaws, creating a Transcript Notation Resolution, and creating a Canvas course to further outreach.
- FLC: ASFLC, played a role in naming the new PEAC2E program- Peer Engagement for Achievement, Culture, Connection, and Excellence (PEAC²E). This program is geared towards enhancing the educational experience for Black/African-American students at Folsom Lake College. In addition, a

presentation was provided by the Region II Treasurer and Delegates regarding a Region II Fundraiser.

- SCC: SCC has been planning for student elections, a Spring 2021 Destress Fest, monthly club days, and a community discussion on the National Election outcomes in partnership with the instruction department.

Leadership Development Accomplishments (i.e. conferences, trainings, workshops, guest speakers):

- ARC: N/a

- FLC: FLC held general training for board members. In addition, Lobby Day training is being planned by the Director of Legislative Affairs for ASFLC to occur on Feb. 16, 2021.
- SCC: SCC has planned a social media training from PIO Kaitlyn Collignon. In addition, student leader training is now available via the Student Government 300 course. Student leaders are reporting they are appreciating the new structure and are able to get more done.
