This report is to be used as a guide for the Student Advisory Committee representative and the Student Trustee in presenting the monthly student report at Board of Trustee (BoT) meetings. Only the information on this report will be used.
The Student Trustee, in consultation with the Student Trustee Advisor, will compile these submissions for one comprehensive report which is due to District Advisor Dr. Rosario, the designated student speaker, and SAC Advisor by noon the Friday before the BoT meeting. Late submissions/unauthorized reports will not be presented at the BoT meeting.

Student led-activities (i.e. March in March, campus events, fundraisers):

- ARC: Donated \$2,000 to the Black History Comic Relief event on Friday, Feb 26th. Held a SHPE
 Resume Workshop. Multiple events were held by TRIO STEM. A speaker event was held by the
 Model United Nations Club. Speaker Presentations were hosted by the Progessive Democrats and
 Sociology Club (including one on the impacts of COVID on low-income populations).
- CRC: n/a
- FLC: Held Club Fair on March 12th and have been actively involved in planning the Region II Fundraising Event.
- SCC: Held a Virtual Clubs Day with 10 participating clubs, and over 50 students in attendance. They are preparing a post-presidential election panel discussion, drafting a support statement to oppose Asian American hate speech/behavior, and are drafting a sexual assault awareness campaign.

Senate and Clubs & Events Board Accomplishments (i.e. surveys, engagement in campus and regional governance):

- ARC: Continued work in preparation for a Virtual Club Day to be held on March 18th. They held a
 BoothCentral training, received a financial aid update, and made decisions on SSCCC General
 Assembly voting.
- CRC: Continued work on the Diversity Day Event, and made decisions on SSCCC General Assembly voting.
- FLC: Plans to participate at SSCCC General Assembly. One of the officers is the author of one of the statewide resolutions that will be presented at General Assembly. Created an ASFLC website, and will be creating an ASFLC Canvas shell.
- SCC: Student leaders are participating on the curriculum committee, College Council, Chancellor's Cabinet, hiring committees, SSCCC, and General Assembly.

Leadership Development Accomplishments (i.e. conferences, trainings, workshops, guest speakers):

- ARC: Three students participated in Lobby Day.
- CRC: Appointed Daniel Xing as a Student Senate Senator, developed the Ad Hoc Election Committee, and had two Student Senate members attend Lobby Day.
- FLC: One student attended Lobby Day. Monthly training sessions have been held. Received a
 presentation on the PEACE program from Dean Kellie Butler and Vice President of Student Services
 Sonia Ortiz-Mercado. Many ASFLC members have been involved in the development of the
 program.
- SCC: Participated in the first ever Virtual Lobby Day with six student leaders in attendance to advocate for Cal Grant reform. Student leadership required training has been met by participation in the SGVT 300 course.. A district-wide event for Bystander Playbook Training hosted by Andre Coleman will be held 3/24 for ALL students.
