Student led-activities (i.e. March in March, campus events, fundraisers):

- ARC: UNITE Center engagement projects- board members assigned as liaisons to our equity programs within the UNITE center. Hold Space events co-hosted by Senate on March 18 and March 21
- CRC: Tabling for Earth Day on April 20th. Collaborating with Valley High School for Student Service Day event on April 21st. Hosting Spring Fest event from April 26th – 28th. Encouraging students to vote in upcoming elections for next term
- FLC: N/A
- SCC: Created a mandatory candidate orientation flyer and worked with candidates to prepare for elections. Created a self-enrollment option in resource hub for students to participate and access modules

Senate and CAEB Accomplishments (i.e. surveys, engagement in campus and regional governance):

- ARC: Center for Leadership and Development Furniture Bill passed on March 18: allocated up to \$20,000 to welcome students back to ASB and CLD offices to support student clubs and organizations to meet in new hybrid format. Pride Center Library Bill passed on April 8: passed \$2,000 in funds to support the PRIDE Center Library.
- CRC: Tabled for the upcoming elections on March 24th & 28th to encourage students to run

- SCC: Created a time capsule ad hoc to gather input and implement an itinerary for the incoming board. Created an ad hoc committee to draft and finalize a personal response to President Dixon from the SCC Senate in support of her.
