2. REPORTS

1. Student Trustee Report

Trustee Pham shared updates on district meeting outreach, noting accessibility challenges, and reminded members that SSCCC resolutions are due in February.

2. Student Leadership and Development Educators (SLADE) Advisor Report

Advisor Anaya reported on Ballot Bowl voting results, recognizing American River College and Cosumnes River College as statewide student voting champions, placing 6th and 5th respectively.

Advisor Ortiz-Mercado shared updates on the Chancellor search, with finalists expected the following week. She discussed district efforts related to artificial intelligence implementation and noted the language change from "probation" to "academic notice."

4. NEW BUSINESS & ACTION ITEMS

1. Lobby Day Topics

Mark McDonald reviewed the Board of Governors' advocacy process and outlined priority areas, including core funding, categorical programs, student housing, and technology support, and budget context. Key concerns discussed included the loss of federal diversity grants and accessibility, and course availability.

2. Senate Bill 707: Brown Act Updates

Chief Counsel Aly Bivins reviewed SB 707, effective January 1, 2026, outlining teleconferencing requirements for student governing bodies, approval processes, public access requirements, and compliance obligations. The bill expires in 2030.

3. Artificial Intelligence in Los Rios

Members discussed district AI framework development, campus AI usage, instructional practices, and the need for transparency, opt-out considerations, and AI literacy for students and faculty.

4. Food Security & Basic Needs

The committee discussed campus food pantry utilization, expanded access initiatives, support for unhoused students, and coordination of basic needs services districtwide.
