Proposed Student Advisory Committee Resolution Procedures

- **Resolution Development:** Local Student Senate passes resolution first before being shared with District leadership and counsel for review prior to first reading during a SAC meeting.
- First reading: All SAC resolutions require a first reading during a scheduled SAC meeting.
 - During this meeting, student leaders can provide feedback and recommendations for editing but will wait for a second reading to approve the resolution.
- Local review Presidents (or their SAC designee) will return to their local Senates to have all the Los Rios Student Senates review before the next SAC meeting.
- **Second reading,** the resolution returns for a formal vote.
 - Resolutions should be provided no later than (2 weeks) before the posting of the SAC agenda.
 - The resolutions should be sent to the Student Trustee, SLADE Advisor, and District SAC
