WHEREAS, Los Rios Community College District (DISTRICT) and Elevator Industries, Inc., (VENDOR) entered into a contract for Bid # 17015 effective July 1, 2017 to June 30, 2018 (CONTRACT); and,

WHEREAS by the 1st Amendment to this CONTRACT the parties extended the CONTRACT to June 30, 2019; and,

WHEREAS by the 2nd Amendment to this CONTRACT the parties extended the CONTRACT to June 30, 2020; and,

WHEREAS, the parties now desire to amend the CONTRACT

NOW, THEREFORE, the parties agree as follows:

1. Extend the existing CONTRACT for a period of 12 months from July 1, 2020 thru June 30, 2021 at the current price of \$8,677.80 per month.
2. All other terms and conditions of the Contract shall remain in full force and effect.
