This Addendum has been acknowledged in the space provided on the Bid Form and is considered part of the bid documents.

Addendum 2 answers questions received. This addendum is 66 pages:

- 1. We would appreciate if we could extend the deadline to November 18, 2019 so that we can give this invitation for bid the best possible response.
 - Answer: The deadline was extended to November 14, 2019, 2:00pm in Addendum 1.
- 2. Retail: Bottle/Can Questions
 - a. Can you provide a breakdown by package size and flavor of all products that are sold through the cafeterias and student stores and any other locations that make up the volume of 24,000 cases that was stated in the RFP?

b. Can you provide the equipment type and size along with the total number of pieces of equipment that support the sale of the 24,000 cases? (Student Store, Cafeterias, Athletics, etc)

Answer: See attachment 3 to this Addendum.

3. Full Service Questions

a. Can you provide the current full service vend prices for all packages sold thru the vending machines and are these the prices you want to use for the RFP?

Answer: See attachment 2 to this Addendum.

4. Fountain Questions

a. Can you provide a volume breakdown by flavor of all fountain products that make up the 3,500 gallons?

Answer: See attachment 2 to this Addendum.

b. Can you provide the breakdown on cups and lids by package size sold?

Answer:

Cups: 60 cases; 50% 16oz, 20% 24oz, 30% 32oz.

Lids: 30 cases; 95% 16-24oz, 5% 32oz.

- 5. Are we able to view the previous contract for the beverage service agreement?
 - a. If not, is this public information and where would it be available?

Answer: Yes, part of the public information act. See attachment 1 to this Addendum.

6. Is there an available product volume breakdown by beverage category or product (water, CSD, energy, etc.)?

Answer: See attachment 2 to this Addendum.

7. Is there an allowance for other suppliers/vendors' products for any retail locations (including bookstores)?

Answer: Not sure what is meant by 'allowance'. This is an exclusive contract with the exceptions noted in the RFP.

- 8. What is the total number of cold equipment (non-vending) for all locations? *Answer: See question #2.b above.*
- 9. What is the total number of fountain equipment for all retail locations?
 - a. Are ice machines supplied by the beverage provider?

Answer: Currently, no.

10. What is the total number of fountain & cold equipment at stadiums, theaters, gyms, & sports fields?

Answer: See question #2.b above.

a. Is there an attendance breakdown per each location?

Answer: No.

- 11. Need for other Points of Sale (Texas tankers, ice barrels, & hawking trays)?

 Answer: Varies by campus, details not available, bid to RFP stated requirements.
- 12. What are the expectations of any third party operators for concessions?
 - a. Example: Subway Sandwiches-follow national beverage contract or winning beverage agreement provider?

Answer: Winning beverage agreement provider, as noted in RFP.

- 13. What are product delivery expectations?
 - a. Centralized storage or individual account deliveries? *Answer: Varies by campus. To be addressed with winning bidder.*
 - b. How many individual accounts per each college location? *Answer: Varies by campus. To be addressed with winning bidder.*
 - c. What are expectations for the available delivery days per week, per location? *Answer: Varies by campus. To be addressed with winning bidder.*
- 14. What are the estimated costs associated with the available sponsorship activities that are currently available?

Answer: See RFP, cost information is not available.

15. Is there an option of utilizing a licensed third party operator for service and maintenance of vending machines and fountain equipment following set guidelines in the RFP for maintenance and service?

Answer: Only if the contractor has ascertained that the subcontractor abides by all conditions of the RFP and has appropriate insurance as required by the RFP.

- 16. What are the expectations of the associate sales and merchandising functions?
 - a. Sales Representatives for each college location?

Answer: This is up to the contractor, to determine how many representatives are necessary to appropriately service the District.

b. Merchandising of retail locations?

Answer: Yes, per RFP.

BEVERAGE AGREEMENT

THIS AGREEMENT ("Agreement") is made effective as of January 1, 2015 ("Effective Date") between Bottling Group, LLC and its affiliates and/or respective subsidiaries collectively comprising Pepsi Beverages Company, having an office at 7750 Reese Road, Sacramento, California ("Sponsor") and the Los Rios Community College District having is principal place of business at 1919 Spanos Court, Sacramento, California 95825 (the "College District").

RECITALS

WHEREAS, Sponsor desires the right to be the exclusive supplier of beverages to the College District.

WHEREAS, Sponsor is experienced in installing, operating, servicing and maintaining equipment for dispensing beverage products and the College District has determined that it is in its best interests to contract with Sponsor to provide services for the sale of beverage products; and

WHEREAS, the parties desire to confirm the terms and conditions under which the College District will contract with Sponsor to install, operate, service and maintain all equipment dispensing beverage products; and

NOW, THEREFORE, in consideration of the mutual promises herein contained, the parties hereto agree as follows:

I. <u>Definitions.</u>

"Agreement Year" means each twelve-month period beginning with the first day of the Term.

"Beverage" or "Beverages" means all carbonated or non-carbonated, nonalcoholic beverages or soft drinks, including, but not limited to, carbonated soft drinks, fruit juices, fruit juice-containing drinks, and fruit-flavored drinks; ready-to-drink coffee products; tea products; hypertonic, isotonic, hypotonic drinks, and fluid replacement drinks; energy drinks; packaged carbonated or still water products; liquid concentrate teas ("LCT"); frozen carbonated and non-carbonated beverages ("FB") and any future categories of nonalcoholic beverage products that may be distributed by Sponsor during the Term.

"Campus" means the entire premises of every school and facility owned or operated by the College District or its Food Service Provider, now or in the future, including all buildings, the grounds, parking lots, athletic facilities and concession stands, snack bars, food carts, book stores,

convenience stores, dining facilities, unbranded and branded food service outlets, retail outlets and vending areas. "Campus" shall also be deemed to include convenience store operations and restaurants in space leased to third-party commercial tenants within College District-owned buildings.

"College District Marks" shall mean the College District's characters, colors, emblems, designs, identifications, logos, mascots, name, service marks, symbols, trademarks, all trade names, uniforms and other proprietary designations which are owned, licensed to or controlled by the College District and which relate to the Facilities and which are in existence on at the beginning of the Term or which will be created during the Term. For clarity purposes, College District Marks shall include, without limitation, characters, colors, emblems, designs, identifications, logos, mascots, name, service marks, symbols, trademarks, all trade names, uniforms and other proprietary designations associated with or related to all intercollegiate athletic teams associated with the College District, at the beginning of the Term or which will be created during the Term, if any.

"Competitive Products" means any and all Beverages other than Products (as defined herein).

"Food Service Provider" shall mean any and all food service providers which may serve at the Facilities at any point during the Term. The College District acknowledges and agrees that this Agreement, including the pricing, funding and other consideration provided for herein is based on the College District's current operating model/use of third party Food Service Providers. Thus, in the event that: (i) if the College District is currently self-operated, the College District switches to a Food Service Provider, or (ii) if the College District currently uses a Food Service Provider to operate its concessions, such agreement between the College District and the current Food Service Provider expires or is terminated, and the College District enters into a new arrangement with a Food Service Provider; then any such new or subsequent agreement between the College District and any Food Service Provider (pursuant to either (i) or (ii) above) shall require such Food Service provider to abide by the applicable pricing and other terms set forth in this Agreement to the exclusion of all other benefits, and shall specifically require such Food Service Provider to affirm that it will not be entitled or seek to receive any funding or other benefits/consideration in connection with any agreement such Food Service Provider may separately have with Pepsi or Pepsi's affiliates. In the event that the College District fails to adhere to this requirement (or the Food Service Provider refuses to abide accordingly), then College District hereby authorizes Pepsi, and Pepsi shall be entitled to adjust its pricing, funding or other consideration provided to the College District by an amount equal to the incremental costs incurred by Pepsi as a result of the College District's change in Food Service Providers.

"Products" shall mean Beverage products manufactured, sold or distributed, now or in the future by Sponsor.

"School Year" means consecutive calendar days running from July 1 of a year through June 30 of the following year.

"Team" or "Team(s)" means all interscholastic athletic teams associated with the College District.

II. <u>Term.</u>

The term of this Agreement shall be Five (5) years, beginning on the Effective Date of this Agreement and ending December 31, 2019 ("Term") unless sooner terminated as provided herein.

III. <u>Exclusive Beverage Availability and Sponsorship Rights.</u>

- (A) The College District hereby grants to Sponsor the following exclusive Beverage availability rights:
 - 1. Sponsor shall have the exclusive right to make Beverages available for sale and distribution on Campus, including through food service and vending and the exclusive right to provide all Beverages sold at athletic contests, student government activities, booster club activities and all other special events conducted at or any location on the Campus ("Special Events"). Subject to the terms and conditions set forth in this Agreement, the College District agrees that Products shall be the exclusive Beverages advertised, promoted, sold, dispensed or served or available on the Campus. Notwithstanding the foregoing, student groups shall have the option, during times of fund raising activities, to sell generic branded bottled or canned products.
 - 2. Sponsor shall have the exclusive right to install full service Beverage vending machines ("Vending Machines"), retail single-serve food service equipment ("Retail Equipment") and fountain beverage equipment ("Fountain Equipment") throughout the Campus (collectively, the "Equipment") at no cost to the District. Sponsor shall install and maintain the Equipment at its sole expense. Sponsor shall, at its sole expense, install and maintain the Equipment in accordance with the minimum food safety guidelines and practices established by national health and safety organizations, federal, state and local laws and ordinances. Sponsor shall, at its sole expense, keep the Equipment in a sanitary, presentable and serviceable condition. Equipment requiring frequent maintenance must be replaced upon written request of the College District. All Equipment that accepts credit cards and/or debit cards as payment must meet all PCI compliance standards. All Equipment must meet state and federal accessibility standards for the disabled. Sponsor shall have the right to place full trademark panels on all sides of its Vending Machines. The College District reserves the right to approve all advertising, in advance of, and all publicly attended special events. Sponsor or one of its affiliates, shall retain title to all Equipment. Sponsor and the College District shall mutually determine the number of Vending Machines on the Campus and their location. Every year of the Agreement the parties will reexamine the needs of the College District to determine any increases to the number of Vending Machines and changes in location. District shall provide water, electricity and drainage within five feet of each Vending Machine requiring utilities. College District will make every reasonable effort to assist and cooperate

- with Sponsor in deterring and preventing damage to equipment or pilferage therefrom, but will not be liable for such damage or pilferage.
- 3. Except as provided in Section III(A)(1) the College District shall purchase, and shall require that all food service providers, concessionaires, student government activities and athletic events selling or distributing Beverages on Campus purchase all Products, cups lids and carbon dioxide directly from Sponsor at the prices established by this Agreement.
- 4. Sponsor shall have the exclusive right to merchandise Beverages on Campus during the Term. The College District agrees that Sponsor's trademarks shall be listed on all menu boards at concession locations where Products are served to customers on Campus. The College District further agrees that all Products served, or dispensed at concession locations will be served in approved Pepsi-identified cups purchased from Sponsor.
- 5. Sponsor shall have the exclusive right to advertise and promote Beverages on Campus and in connection with the College District, the College District Marks and the Teams (as defined below). Sponsor shall have the right to display Pepsi-identified banners and signage on Campus in locations mutually determined by Sponsor and the College District. The College District agrees that Sponsor shall have the right to promote (with College District pre-approval) the fact that Sponsor is the exclusive Beverage sponsor of the college District and that the Products are available on Campus. The College District grants to Sponsor a nonexclusive license to use the name of the Campus and the College District Marks for the purpose of promoting (with College District pre-approval) the Products within the context of promotional activities provided for in this paragraph.
- 6. Each Year during the Term, the College District will provide Sponsor with up to ten (10) complimentary tickets to each athletic event conducted on College District Campuses as reasonably request by Sponsor from time to time.
- (B) College District recognizes that Sponsor has paid valuable consideration to ensure an exclusive associational relationship with the Campus, College District and/or the College District Marks and College District's athletic teams ("Teams") with respect to Beverages and that any dilution of diminution of such exclusivity seriously impairs Sponsor's valuable rights. Accordingly, the College District will promptly oppose Ambush Marketing (as defined below) and take all reasonable steps to stop Ambush Marketing and to protect the exclusive associational rights granted to Sponsor pursuant to this Agreement. In the event any such Ambush Marketing occurs during the Term, each party will notify the other party of such activity immediately upon learning thereof. As used herein, "Ambush Marketing" an attempt by any third party, without Sponsor consent, to associate Competitive Products with the Campus, College District, the College District Marks and/or Team, or to suggest the

Competitive Products are endorsed by or associated with the Campus, College District, the College District Marks and/or Team by referring directly or indirectly to the Campus, College District, the College District Marks and/or Team.

IV. <u>American River College and Cosumnes River College Culinary Arts Programs.</u>

The American River College and Cosumnes River College Culinary Arts Program and their operations are not required to exclusively sell only Pepsi Products at their facilities, as is otherwise required under this Agreement. These locations are, however, required to use Pepsi as their primary Beverage supplier and purchase the majority of their Beverage products directly from Pepsi throughout the Term except when academic programs require a non-Pepsi product. Notwithstanding the foregoing, Customer agrees that in no event shall there be served, dispensed or otherwise made available, or in any way advertised, displayed, represented or promoted, beverage products licensed by, or produced by bottlers licensed by, The Coca-Cola Company or any affiliate thereof at American River College and Cosumnes River College Culinary Arts Programs.

V. <u>Pricing and Products.</u>

(A) Vending products to be offered are certain Products as determined by Sponsor from time to time.

Vend prices are as set forth in Section VI (B) herein. Any additional pricing changes shall be negotiated and mutually agreed upon by the Sponsor and the College District.

(B) Pricing for Products and for cups, lids and CO2 purchased by the College District and the Food Service Providers and other third parties selling or distributing Products on Campus are listed in the attached Exhibit A. The College District recognizes that such pricing shall remain fixed through July 31, 2015. Any pricing changes thereafter shall be determined by Sponsor upon 30 days prior notice to and written approval of the College District, which approval shall not be unreasonably withheld. Sponsor pricing increase will not exceed more than 4% annually.

VI. <u>Consideration</u>.

- (A) Annual Sponsorship Fee. In consideration of the exclusive rights granted in this Agreement, Sponsor shall pay to the College District a sponsorship fee in the amount of One Hundred and Fifty Thousand Dollars (\$150,000) per Year (the "Annual Sponsorship Fee"), payable within ninety (90) days after the end of each Agreement Year, not to exceed five (5) consecutive payments.
- (B) <u>Commissions.</u> In consideration of the rights granted by The College District hereunder, during the Term Sponsor agrees to pay The College District a commission rate of 38% on all vend products ("Commission Rate"), as a percentage of the actual cash ("cash in bag" or

"CIB") collected by Sponsor from the Vending Machines placed at the Campus, less any applicable fees or deposits ("Commissions"). Commission Rate shall be calculated as follows:

(CIB * Commission Rate) – Applicable CRV = Commissions due

(C) <u>Commission Payment</u>. Commissions shall be remitted by Sponsor to The College District within 30 days of the end of each of Sponsor's four-week accounting periods during the Term. Sponsor shall make all pertinent revenue and sales records respecting the Vending Equipment available to The College District. The College District acknowledges and agrees that Sponsor established the Commission Rate based on any applicable sales tax associated with the sale of the Products through the Vending Machines as of the commencement date of this Agreement. If, during the Term, applicable sales taxes should increase by more than five percent (5%), then Sponsor shall have the right to automatically reduce the Commission Rate by the same percentage amount.

VII. Additional Consideration.

In addition to the consideration specified in Section V above, Sponsor shall provide the following further consideration to the College District:

- (A) Sponsor will accrue rebates on behalf of the College District at a rate of \$4.00 per 24-unit case and \$2.00 per 12-unit case on all bottle and can cases (the "Bottle/Can Rebates"). The Bottle/Can Rebates will be paid on all Products purchased through Sponsor and sold on Campus. The Bottle/Can Rebates will be paid within ninety (90) days after the end of each Year.
- (B) Sponsor will provide the College District with scholarship funds of Four Thousand Dollars (\$4,000) on an annual basis, not to exceed five (5) consecutive payments. This payment is due within 90 days after the end of each Agreement Year.

- (C) Sponsor will provide the College District with sustainability funds of Four Thousand Dollars (\$4,000) on an annual basis, not to exceed five (5) consecutive payments. This payment is due within 90 days after the end of each Agreement Year.
- (D) Sponsor will provide the College District with flex funds of Twenty Thousand Dollars (\$20,000) on an annual basis, not to exceed five (5) consecutive payments. This payment is due within 90 days after the end of each Agreement Year.
- (E) Sponsor will provide the College District with athletic hydration support products valued at up to Four Thousand Dollars (\$4,000) on an annual basis as requested by the College District. The College District will give Sponsor two (2) weeks advance notice for all athletic hydration support product requests. The College District acknowledges that value of unrequested product in any Year will not be carried over to a subsequent Year and will not be redeemable for a cash value.
- (F) Sponsor will provide the College District with Donated Product on an annual basis valued at up to Three Thousand Five Hundred Dollars (\$3,500). This Product will consist of 12 oz. cans of carbonated soft drinks and 16.9 oz. water. The College District will give Sponsor two (2) weeks advance notice for all Donated Product requests. The College District acknowledges that value of unrequested Product in any Year will not be carried over to a subsequent Year and will not be redeemable for a cash value.

Sponsorship funds are all paid at the end of each Agreement Year and will be utilized at the discretion of the College District provided funds are used within the intent of the Agreement and do not detract from the Sponsor name and/or reputation.

VIII. <u>Competitive Products.</u> During the entire Term of this Agreement:

- (A) No Competitive Products shall be sampled, sold, served or dispensed anywhere on the Campus:
- (B) No permanent or temporary advertising, signage or trademark visibility for Competitive Products shall be displayed anywhere on the Campus, including locker rooms, sidelines and players benches; and
- (C) No agreement will be entered into or maintained by the College District pursuant to which Competitive Products will be associated with the College District or the Campus in any advertising or promotional activity that creates a relationship or connection between Competitive Products and the College District, Campus, schools or Teams.

IX. <u>Equipment and Service.</u>

(A) During the Term and at no cost to the College District, Sponsor will service and stock, if necessary, (i) the Equipment and (ii) any additional Equipment determined by the parties to be

installed at new location on the Campus. Sponsor or one of its subsidiaries or affiliates shall retain ownership in and title to all Equipment. Equipment shall be installed and operational in the places identified in this Agreement within two (2) business days of the commencement of this Agreement, or at such other date as otherwise mutually agreed in writing. Contractor shall meet all obligations set forth in Section III Scope and Specification of Equipment and Services of the Request for Proposal dated October 3, 2014.

- (B) The equipment may not be removed from the Campus without Sponsor's written consent, and the College District agrees not to encumber the Equipment in any manner or permit other equipment to be attached thereto except as authorized by Sponsor. Within thirty (30) days after the end of the Term, Sponsor shall remove all equipment from the Campus at no expense to the College District. If Sponsor has not removed the Equipment within such 30-day period, the College District will send written notice to Sponsor to remove the Equipment. If Sponsor does not respond to the written notice within ten (10) days, the College District may remove and store the Equipment and Sponsor will reimburse the College District for all removal and storage costs.
- (C) Sponsor's service of the Equipment will be provided during normal College District hours and Sponsor will not be obligated to provide service during periods in which it is prevented from doing so due to strikes, civil disturbances, unavailability of parts or other causes beyond the control of Sponsor.

X. <u>Product Stocking</u>.

The College District shall permit Sponsor, its employees, agents and representatives to enter the Campus for purposes of servicing and stocking the Equipment during normal College hours.

XI. <u>Taxes and Permits.</u>

Sponsor shall be responsible for the payment of all taxes, permits, licenses and fees applicable to its property, income and business, arising out of or in connection with the performance of this Agreement. The College District shall not reimburse Sponsor for any direct or indirect tax imposed on it by reason of this Agreement. The College District acknowledges and agrees that neither Sponsor nor its affiliates shall be responsible for any taxes payable, fees or other tax liability incurred by the College District in connection with any fees payable by Sponsor to the College District under this Agreement. In addition, Pepsi shall be responsible only for the payment of taxes on the sales of Products through Vending Machines. Pepsi shall not be assessed common area maintenance fees, taxes or other charges based on its occupation of the space allocated to its Equipment.

XII. Representations, Warranties and Covenants.

- (A) <u>Representations, Warranties and Covenants of the College District.</u> The College District represents, warrants and covenants to Sponsor as follows:
 - (1) The College District has the full power and authority to enter into this Agreement and to grant and convey to Sponsor the rights set forth herein;
 - (2) All necessary approvals for the execution, delivery and performance of this Agreement by the College District have been obtained and this Agreement has been duly executed and delivered by College District and constitutes the legal, valid and binding obligation of the College District enforceable in accordance with its terms, and nothing contained in this Agreement violates, interferes with or infringes upon the rights of any third party;
 - (3) The signatory of this Agreement is duly authorized and empowered to bind the College District to the terms and conditions of this Agreement for the duration of the Term; and
 - (4) The College District has complied with all applicable laws, ordinances, codes, rules and regulations relating to its entering into this Agreement and its performance hereunder.
- (B) <u>Representations, Warranties and covenants of Sponsor</u>. Sponsor hereby represents warrants and covenants to the College District as follows:
 - (1) Sponsor has full power and authority to enter into and perform this Agreement;
 - (2) All necessary approvals for the execution, delivery and performance of this Agreement by Sponsor have been obtained and this Agreement has been duly executed and delivered by Sponsor and constitutes the legal, valid and binding obligation of Sponsor enforceable in accordance with its terms and nothing contained in the Agreement violates, interferes with or infringes upon the rights of any third party:
 - (3) The signatory of this agreement is duly authorized and empowered to bind Sponsor to the terms and conditions of this Agreement for the duration of the Term: and
 - (4) Sponsor has complied with all applicable laws, ordinances, codes, rules and regulations relating to its entering into this Agreement and its performance hereunder.
- (C) General. Each of the parties hereto agree that (i) the representations, warranties and covenants contained herein shall survive the execution and delivery of this Agreement, and (ii)

except as expressly set forth herein, neither party has made, and neither party is relying on, any representation or warranty, express or implied, with respect to the subject matter hereof.

XIII. Indemnification.

(A) Sponsor shall defend, indemnify, and save harmless College District (including its trustees, officers, agents, members, and employees), and each of them, of and from any and all claims, demands, suits, causes of action, damages, costs, expenses, attorneys' fees, losses, or liability, in law or in equity, of every kind and nature whatsoever related to, arising out of, or in connection with, Sponsor's work or services to be performed under this Agreement, including, but not limited to personal injury to any person, death to any person, damage to any property, penalties, infringement of patent rights, claims and liens for labor performed or materials, failure to comply with the provisions requiring insurance, any violation by Sponsor of any law, order or regulation arising out of or resulting from this Agreement.

The obligations set forth in this section shall not be limited by the insurance requirements set forth herein.

Sponsor's indemnification obligations shall not include indemnification for claims which arise as the result of the active negligence of District, or the sole negligence or willful misconduct of District, its agents, servants or independent contractors who are directly responsible to District.

(B) The provisions of this Section XII shall survive the termination of this Agreement.

XIV. Breach of Contract and Termination

- (A) If (i) any of the Products are not made available as required in this Agreement by the College District, their agents or concessionaires; (ii) any of the rights granted to Sponsor herein are materially restricted or limited during the Term of this Agreement; or (iii) a final judicial opinion or governmental regulation prohibits the availability of Beverages, whether or not due to a cause beyond the reasonable control of the College District, then Sponsor may give the College District written notice of such event and the College District shall have a thirty (30) day period within which to cure such breach. If the College District fails to cure such breach within a thirty (30) day period, Sponsor may terminate this Agreement in its entirety upon written notice to The College District.
- (B) The College District may terminate this Agreement for any breach of this Agreement's material terms by Sponsor. Sponsor shall perform its obligations under this contract in accordance with the industry standards and generally accepted customer service and sound business practices. The College District shall document incidents of poor service performance by Sponsor and submit them to Sponsor for response and correction. Failure of Sponsor to correct this poor performance within 30 days of written notice shall constitute breach of this Agreement. The College District shall provide Sponsor with written notice of any breach and

provide a thirty (30) day opportunity for Sponsor to cure such breach. If Sponsor fails to cure the breach within the thirty (30) day period, the College District may terminate the Agreement upon written notice to Sponsor

- (C) Without prejudice to any other right or remedy available to either party at law or in equity of any event described below, this Agreement may be terminated by either party if the other party, or any parent of such other party, shall (1) have an order for relief entered with respect to it, commence a voluntary case or have an involuntary case filed against it under any applicable bankruptcy, insolvency or other similar law now or hereafter in effect (and such order or case is not stayed, withdrawn or settled within sixty (60) days thereafter) it is the intent of the parties hereto that the provisions of Section 365(e)(2)(A) of Title 11 of the United States Code, as amended, or any successor statue thereto, be applicable to this Agreement; or (2) file for reorganization, become insolvent or have a receiver or other officer having similar powers over it appointed for its affair in any court of competent jurisdiction, whether or not with its consent (unless dismissed, bonded or discharged within 60 days thereafter); or (3) admit in writing its inability to pay its debts as such debts become due.
- (D) The rights of termination referred to in this Agreement are not intended to be exclusive and are in addition to any other rights available to either party in law or in equity.

XV. Notices.

Any notices or other communication hereunder shall be in writing, shall be sent via registered or certified mail, and shall be deemed given when received.

XVI. Relationship of Parties.

(A) The College District and Sponsor are acting herein as independent contractors and independent employers. Nothing herein shall create or be construed as creating a partnership,

joint venture or agency relationship between any of the parties and no party shall have the authority to bind the other in any respect. Sponsor and any person employed by or conducting business with the College District shall not be a partner, employee, agent or joint venture of the College District. The sole relationship of the parties hereto created by this Agreement is that of licensor and licensee.

(B) No goods or equipment shall be purchased in the name of the College District by Sponsor or any person employed by or conducting business with Sponsor nor shall any goods or equipment be purchased by the College District in the name of Sponsor. No debts, liabilities, obligations or contracts of whatever kind made or incurred by either of the parties hereto or any person employed by or conducting business with said party shall be in the name or upon the credit of the other party, and the other party shall not be liable or responsible therefor.

XVII. Retention of Rights.

The College District shall not obtain by virtue of this Agreement, any right, title or interest in the trademarks of Sponsor nor shall this Agreement give the College District the right to use, refer to, or incorporate in marketing or other materials the name, logos, trademarks or copyrights of Sponsor.

XVIII. Confidentiality.

Except as otherwise required by law or the rules or regulations of any national securities exchange or the rules or regulations of the College District, the College District and Sponsor agree not to disclose any information with regard to the terms of this Agreement ("Confidential Information") to any third party other than to their respective directors, officers, employees and agents (and directors, officers, employees and agents of their respective Affiliates) and advisors (including legal, financial and accounting advisors) (collectively, "Representatives"), as needed. Sponsor acknowledges this Agreement may be disclosed upon receipt of a request for disclosure, pursuant to California Public Records Act ("the Act"). If a request is received by College District under the Act, the College District shall give notice to Sponsor of that request. Sponsor shall then have five (5) days from the date it receives such notice to enter into an agreement with the College District, satisfactory to legal counsel for the College District, providing for the defense of, and complete indemnification and reimbursement for all costs (including plaintiff's attorney fees) incurred by the College District in any legal action to compel the disclosure of such information under the Act. Sponsor shall have sole responsibility for defense of the actual "trade secret" designation of such information. Failure to timely respond or enter into an acceptable agreement shall be deemed to have waived of any rights regarding the information designated "trade secret" by Sponsor, and such information will be disclosed by College District pursuant to applicable procedures required by the Act.

XIX. Governing Law.

This Agreement shall be governed by and construed in accordance with the laws of the State of California without regard to conflicts of laws principles. Any legal proceeding of any nature whatsoever brought by either party against the other to enforce any right or obligation under this Agreement, or arising out of any matter pertaining to this Agreement, shall be submitted for trial, without jury, before the Courts of the State of California, or the United States District Court having jurisdiction in the State of California, or, if neither of such courts shall have jurisdiction, then before any court sitting in the State of California having subject matter jurisdiction. The parties consent and submit to the jurisdiction of any such court and agree to accept service of process inside or outside the State of California in any manner to be submitted to any such court pursuant hereto.

The parties hereto expressly waive all rights to trial by jury regarding any matter arising out of this Agreement.

Sponsor represents and warrants to the College District that Sponsor has, and shall keep in effect, at tis sole cost, all licenses, permits, qualifications, and approvals of whatsoever nature that are legally required for Sponsor to provide any services under this Agreement.

XX. <u>Insurance</u>.

- (A) Each party hereto maintains and agrees to maintain, at all times during the Term, a comprehensive program of risk retention and insurance with such insurance carriers and in such amounts of insurance coverage reasonably acceptable to the other party, including, but not limited to a minimum of \$1,000,000 per occurrence and \$3,000,000 in the aggregate general liability insurance and \$1,000,000 automobile liability insurance. Each party agrees to name the other, and each of its Affiliates, and their respective board members, officers, directors, employees, agents, volunteers, representatives and successors and assigns, as additional insureds on such insurance policies during the Term. Such insurance will contain a waiver of subrogation with respect to the additional insureds. In addition, each party hereto agrees to maintain workers' compensation coverage as required by the Labor Code of the State of California, and Employers' Liability Insurance; with limits as required by the Labor Code of the State of California and Employers' Liability limits of \$1,000,000 per accident.
- (B) Either party shall have the right, during the Term from time to time, to request copies of certificates of insurance, copies of insurance policies, and/or other evidence of the adequacy of the above insurance coverages.

XXI. Entire Agreement.

(A) This document is intended by the parties as the final and binding expression of their agreement and is a complete and exclusive statement of the terms thereof and supersedes all prior negotiations, representations, and agreements and no representations, understandings,

or agreements have been made or relied upon in the making of this Agreement other than those specifically set forth herein.

(B) No modification or waiver of any of the terms and conditions of this Agreement shall be effective unless such modification or waiver is expressed in writing and signed by each of the parties. This Agreement may be amended only in writing signed by each of the parties.

XXII. Assignment: Binding Nature; Multiple Originals.

To the extent permitted by law, this Agreement shall be binding upon and inure to the benefit of Sponsor and the College District and their respective successors and permitted assigns. Neither party may subcontract or assign its rights or obligations under the Agreement to any other entity or person without the express written consent of the other, which consent may be withheld at its sole discretion. Notwithstanding the foregoing, Sponsor shall be entitled to assign its rights and obligations under this Agreement to a subsidiary or affiliate or pursuant to the sale of substantially of its assets. No waiver by any party of any default or non-performance shall be deemed a waiver of any subsequent default or non-performance.

XXIII. Savings Clause.

If any provision of this Agreement shall be deemed or declared unenforceable, invalid or void, the same shall not impair any of the other provisions contained herein which shall continue to be enforceable in accordance with their respective terms, except that this clause shall not deprive any party of any remedy afforded under this Agreement.

XXIV. Employees.

Sponsor shall ensure that persons who perform services on Campus have not been convicted of any felony, or any controlled substance offense or any sex offense as those terms are defined by Education Code Section 87008-87010.

XXV. Equal Employment Opportunity Provisions.

- (A) Compliance with Regulations. Sponsor shall comply with the Executive Order 11246 entitled "Equal Opportunity in Federal Employment", as amended by Executive Order 11375 and 12086 and as supplemented in Department of Labor regulations (41 CFR Chapter 60), hereinafter collectively referred to as the "Regulations".
- (B) Nondiscrimination. Sponsor, with regards to the work performed by it pursuant to this Agreement, shall not discriminate on the ground of race, color, religion, sex, national origin, age, marital status, military status, physical handicap or sexual orientation. Sponsor shall not participate either directly or indirectly in discrimination prohibited by the Regulations.

(C) Information and Reports. Sponsor shall provide all information and reports required by the Regulations, or by any orders or instruction issued pursuant thereto, and will permit access to its books, records, accounts, other sources of information and its facilities as may be reasonably determined by the College District to be pertinent to ascertain compliance with such Regulations, orders, and instructions. Where any information required of Sponsor is in the exclusive possession of another who fails or refuses to furnish this information, Sponsor shall so certify to the College District, and shall set forth what efforts it has made to obtain the information.
