Items discussed:

- 1. Reviewed scope of work.
- 2. Walked site and viewed poles and transformer.
- 3. It was announced 2 addenda have been issued. How can I obtain these? Information from Architect's "Addendum 1 and Addendum 2" mentioned during bid walk are included in issued Project Manual and plans, although the addenda numbers are not referenced.
- 4. Some pole covers are missing. Refer to specifications.
- 5. Grate is bad. Refer to specifications & photos.
- 6. Paint entire poles? Yes.
- 7. Are weight of new LEDs more than existing? No, they weigh less.
- 8. Extend RFI deadline? There is no plan to extend the bid timeline at this time. Refer to specifications.
- 9. How are poles serviced now? Extension ladder.
- 10. No new landings. Refer to specifications.
- 11. Are the light bars at the top being replaced or just the lights? Addendum will be issued.
- 12. If the light bars are being replaced is a new standing area/walkway being provided? Addendum will be issued.
- 13. Is the lower light being removed also? Addendum will be issued.
- 14. What is the height of the poles? Addendum will be issued.
- 15. Is the weight of the lights: more or less than the existing lights? Addendum will be issued.
- 16. Electrical drawings show a new Ground Rod Well. Can the pole be drilled into and what is the maximum size of the hole allowed? Addendum will be issued.
- 17. Are the conductors new or being reused? Addendum will be issued.
- 18. What is the height of the hill that the 100'-0" poles are located on top of? Addendum will be issued.
- 19. Can a crane be placed on the track within the field area? Addendum will be issued.
